

Overcoming Barriers

Grand Junction Curbside Recycling Indefinitely (GJ CRI):

- Cost ranges from \$21-25 per year and service is one or two pick-ups per month;
- CRI markets recyclables in the US; and
- Very low contamination rates due to education and four streams.

Grand Junction CRI

Received \$306,187 from the Resource Recycling Economic Opportunity Fund to build building and baler for cardboard

-Increased the capacity of the facility from 3.5 million pounds to 9 million pounds of material and created one new position

Northern Colorado Landfills

Landfills in Larimer, Weld, Logan, Morgan, Sedgwick, Phillips and Yuma Counties collected approximately **1,377,064** Tons for disposal in 2012



Assumptions

- 1. 15% of waste entering landfills could be composted or recycled into organic product
 - EPA says 30% of waste sent to landfills every year is food and yard waste
- 2. 23% of waste entering landfills could be recycled
 - EPA says 46% of waste sent to landfills could be recycled
