PROPOSAL DESCRIPTION

- Development site: 2.6 acres
- Construct new mixed-use building; ground floor office (5,000 sf) and 110 senior multifamily units above
- Height: 3 stories
- 88 parking spaces
- New plaza, landscaping, and stormwater detention areas
- Site is zoned Harmony Corridor (H-C) District. Mixed-use projects with 50 or more multifamily units permitted subject to Planning & Zoning Board review.

MODIFICATIONS REQUESTED

 The proposal includes two modifications to the City Land Use Code, requesting a reduction in the number of project parking spaces and the utilization of a private versus public gathering space.
