PROPOSAL NAME & LOCATION Warren Federal Credit Union Project

Development Plan

Located on the south side of East Drake Road, between Illinois Drive and Iowa Drive (Please see map location with this letter)

PROPOSAL DESCRIPTION

- This is a project review for a 2 acresite located on the south side of East Drake Road, between Illinois Drive and Iowa Drive.
- The proposal divides the site into three lots and one tract.
- Lot 3 is proposed to be developed first, and includes one building for the Warren Federal Credit Union as well as other office and retail uses within the building. The building is two stories.
- Lots 1 and 2 front on Illinois Drive, west of the bank/retail building on Lot 3, and propose future buildings that will be reviewed at a later time. The future buildings include a retail use on Lot 1 and a restaurant use on Lot 2.
- The remaining portion of the site is shared parking located in Tract A, and includes 88 off-street parking spaces.
- The site is located in the Neighborhood Commercial (N-C) zone district.
