This juried exhibition features the ceramic work of Colorado artists in a unique three day exhibition and sale held in the Galleries at the Lincoln Center.

The gallery space is designed as a gallery exhibition but also designed to allow easy access for patrons to touch the works, then purchase it and take it home with them that day. Gallery installation of artwork will be done by the Lincoln Center.

Each accepted artist is asked to donate a few hours of their time during the exhibition and sale. Artists donating time will work with one to two other artists assisting customers by opening display cases for viewing, helping wrap sold item, and answering questions about the pottery and techniques.

Each artist is invited to display no more than 35 pieces of their current work. All artwork entered in the exhibit must be for sale. The Lincoln Center will handle all sales at the exhibition and receives a 35% commission on each sale.
