#### Moratorium Ordinance No. 145, 2012

- Enacted December 18, 2012
  - stopped permitting of any new oil & gas drilling
- Included City-owned property
- In effect until July 31, 2013



#### **Purpose of Moratorium**

<u>Primary</u>: to study the impact of uses and new rules expected by the COGCC and determine whether additional land use and zoning regulations are necessary:

Develop legislative policies

- Draft intergovernmental and operator agreements
- Complete a new public engagement process for LUC regulations




Well Activity: City Limits & City-Owned Natural Areas

#### **Oil/Gas Wells**

- Active
- Shut-in
- ▲ Inactive
  - Current Statewide Setbacks (150-350 ft)

#### What is Hydraulic Fracturing?

- Generally allows for more oil or gas recovery
- A treatment used by the oil and gas industry to stimulate oil and gas recovery by:
  - Injecting fluids, including chemicals, under pressure into the well
  - Designed to fracture geological formations
  - Enhance production of oil and gas
  - Commonly referred to as "fracking"




#### Hydraulic Fracturing Ban: Ordinance No. 032

#### Enacted into City Code March 5, 2013:

- Section 12-135 Storage
  - No open pits or extended storage of processing fluids
- Section 12-136 Exemptions
  - Any oil or gas well or pad prior February 19, 2013
  - Operator Agreement
  - Strict controls on Methane release/air emissions
  - Adequate protection public health, safety and welfare



Existing Wells in Fort Collins City Limits Affected by the Ban




#### Who is Prospect Energy?

#### Prospect Energy, LLC

- Operator of the Fort Collins Field located in the northeast part of the City
  - Field in production since 1924
  - Oil production
  - 7 producing oil wells in City limits
- Leaseholder for mineral interests within the City described as the Undeveloped Area (UDA)
- Intention to continue operating and expand production of existing leases








## UDA Neighborhood & Zoning Map

#### Why are people concerned?

- Air Quality
  - Pollutants, carcinogens, dust, aerosols, odors
  - Haze and acid rain
- Water Quality
  - Methane gas, spills and shallow water contamination, illicit dumping
- Waste and Wastewater
  - Capture, storage and disposal challenges



### Air Quality Controls for Methane Release/Air Emissions

Prospect Energy captures air emissions from tanks and production equipment and routes them to a thermal oxidizer for destruction:

- 98+% of captured emissions destroyed
- COGCC and CDPHE require 90% and 95% depending on equipment
- The % of emissions from current PE operations is low compared to typical shale gas operations
- Control of emissions will also be required in the UDA



### Controls for Air Emissions Continued:

- Closed-loop drilling
- No uncontrolled venting
- Minimal flaring during drilling and completions (24 hour monitoring and 98% control of VOCs)
- Leak Detection and Repair (LDAR)
  - Use a FLIR (Forward-Looking Infrared)
  - Notify the City for observation of testing
- Air monitoring (baseline, completions, response)
- AQ Action Days response plan
- Green Completions on gas wells



#### Water & Wastewater Protections:

#### • Water Quality

- COGCC Rule 609
- Testing Pre & Post Drilling
- Added tests for dissolved metals and soil gas
- Added testing intervals
- Analytical tests shared with City
- Must comply with City stormwater requirements
- Wastewater and Waste Management
  - Closed Loop and pitless systems
  - No discharge of fluids or wastes
  - No long-term storage



### Added Public Health, Safety, & Welfare Protections:

- Setbacks
- Conceptual Review
- Community Notice
- Closed Loop Pitless Systems
- Chemical disclosure and storage
- Electric Equipment
- Emergency Preparedness Plan
- Air Quality Mitigation Plan



### Criteria for Exemption from Ordinance No. 032 Hydraulic Fracturing Ban

- Council approved Operator Agreement
- Strict controls on methane release
- Adequately protects public health, safety and welfare



# Comparison: Operator Agreement vs. Federal and State Guidelines

- Council asked Staff to evaluate areas in the agreement that are equal to or exceed State and Federal guidelines:
  - Air and Water Quality meet or exceed regulations
  - Notice requirements exceed regulations
  - Set-backs and chemical disclosure exceed
  - Emergency Management and training exceed



#### **Status: Operator Agreement**

- First meeting to negotiate March 1, 2013
- Draft submitted March 6, 2013
  - Included the UDA
  - Contained LUC Option B elements
- Operator Agreement adopted March 19, 2013
  - Not in effect without removing moratorium and ban
- Second Reading April 16, 2013
  - Continued to May 21, 2013



#### **Other conditions in Agreement**

- All BMPs apply to New Wells; in City limits
- No further development review process
- If area in GMA annexed, agreement applies
- Most stringent requirements apply
- 5 year term with renewals
- Non-performance clause



#### Council Meeting May 21, 2013

- Council Chamber, 300 LaPorte Avenue 6 p.m.
- Consider adoption of Second Reading exempting Prospect Energy from the Moratorium and the Ban.
- Includes Fort Collins Field and UDA
- Suggested amendments
  - 1000' set backs from residential along south and west portions of UDA
  - No permitted new drilling in plugged and abandoned wells in Fort Collins Field
