The Fort Collins Art in Public Places Program is requesting black & white line drawings that celebrate the history of the Northside neighborhoods: Buckingham, Andersonville/San Cristo/Via Lopez, and Alta Vista. The selected drawings will be sandblasted into granite pavers and incorporated in new sidewalks in these neighborhoods in Fort Collins, Colorado.

PROJECT

This paver project is part of the ongoing implementation of neighborhood projects from the Lincoln Corridor Plan. The City requests **black and white line drawings** that celebrate the history of the Northside neighborhoods (e.g. the Hispanic, German-Russian heritage, sugar beet industry, etc.) For more information on the history, please visit **fcgov.com/Lincoln**. Artists of all ages are encouraged to submit. We also encourage families to create a drawing together. The winning designs will be sandblasted into granite pavers and placed into new sidewalks around the neighborhoods.

TIMELINE

Submission Deadline: Must be received by 5 p.m. on August 28, 2015

Finalists Chosen: September 2015

Installation dates and locations: Fall 2015 to Fall 2016, locations to be determined.

ELIGIBILITY

Artwork will be accepted from artists of all ages. The artists are required to reside <u>within the City of Fort Collins Growth</u> <u>Management Area</u>. To check the boundaries, visit fcgov.com/growth-management-area. Each individual or family group may submit only <u>one drawing</u>.

BUDGET

Artists whose designs have been selected by the committee will be awarded \$50. Up to 10 designs will be selected.

SELECTION PROCESS

The selection committee may consist of the APP Board, up to three representatives from the City's Project Team, and one City Purchasing Department representative. The selection committee reserves the right to reject any or all entries at any time in the review and selection process.

SELECTION CRITERIA

Selection is based on suitability of the design to the theme of this project, including form, content, scale, and clarity. The design should be picture-based, not word-based. Designs that include logos; copyrighted or trademarked images; advertisements; or political, commercial, religious, or sexual symbols, themes, or messages will not be accepted.

APPLICATION MATERIALS TO BE SUBMITTED

- 1. Form: Please complete the attached form with contact information and signatures.
- Design: <u>One</u> black and white THICK, BOLD, CLEAR line drawing (no shading) completed on the attached form. <u>We suggest you</u> <u>use a black marker for drawing or a wide stroke width for digital drawing</u>. Fine, intricate details cannot be duplicated in a sandblasted paver and we reserve the right to edit images for clarity. (See examples of existing pavers on the APP webpage: <u>fcgov.com/pavers</u>)
- 3. Written explanation: A description of your design and theme.
