## **Rules and Regulations**

- 1. This is a subjective contest, and chance plays no part in the determination of winning.
- 2. Contest is open to all residents within Fort Collins city limits. (City of Fort Collins employees and their immediate family members are not eligible to enter)
- 3. Contest begins February 1, 2017 at 12:01 A.M. MT and ends February 28, 2017 at 11:59 P.M. MT.
- 4. To enter, share your photo to #mytrc via Twitter, Facebook, or Instagram. You may also email your entry to msmith@fcgov.com with subject line "#mytrc Entry". Alternatively, entries can be mailed to: City of Fort Collins, 215 N. Mason St., 3<sup>rd</sup> Floor CPIO, Fort Collins CO, 80524. Entry must include your full name and contact information. Entry must also include a parent or legal guardian's full name, telephone number and email address if under the age of 18.
- 5. Entry must be received by the City of Fort Collins no later than 11:59 P.M. MT on February 28, 2017 by social media, email or mail. No other method of entry will be accepted.
- 6. The City reserves the right to reject any or all submissions at any time in the review and selection process.
- 7. Contact and shipping information collected will be used for the purposes of this contest only and will not be used for marketing or other purposes.
- 8. All entries must be entirely created by the entrant.
  - Photographs that include logs, copyrighted or trademark images, advertisements or political, commercial, religious or sexual symbols, themes or messages will not be accepted.
  - Photographs should be appropriate for a diverse, broad-based audience of all ages.
- 9. Entries will be judged by City of Fort Collins staff based on creativity, composition and subject. Two winners will be determined by the judges at their sole discretion. The decisions of the judges will be final and binding in all respects.
- 10. All winners will be selected on or about March 1, 2017. We will contact the potential winners by email on or about March 6, 2017. The name and entry will be posted on the fcgov.com on or about March 10, 2017.
- 11. The prize will be awarded to the winners by the City's CPIO office.
- 12. Non-compliance or return of prize notification as undeliverable, whether by email or telephone, may result in disqualification and selection of an alternative potential winner.

- 13. The City of Fort Collins will identify prizes and may substitute prizes of equal or greater value. In the event of insufficient entries for a category, a winner may not be chosen.
