## CITY OF FORT COLLINS SOLID WASTE AND RECYCLABLE MATERIALS TONNAGE SUMMARY REPORT

### Definitions:

*Residential customers* means residential properties for which there is a curbside collection system for the collection of solid waste. *Recyclable Materials Designated for Residential Customer Collection include:* Aluminum and steel beverage, aerosol and food cans, newspaper (including all inserts), magazines, catalogs, junk mail, glass bottles and jars, and all plastic bottles and jars with opening smaller than the base – check for the neck. **Mandatory collection effective July 1, 2006: corrugated cardboard, brown paper bags, and paperboard.**

*Multi-family customers* means residential properties for which there is a communal system for the collection of solid waste (duplex, condominium, mobile home park, apartment). *Recyclable Materials Designated for Multi-family Customer Collection include:* Aluminum and steel beverage, aerosol and food cans, newspaper (including all inserts), magazines, catalogs, junk mail, glass bottles and jars, and all plastic bottles and jars with opening smaller than the base – check for the neck. **Mandatory collection effective July 1, 2006: corrugated cardboard, brown paper bags, and paperboard.**

**Group account** means a customer account for solid waste collection services that provides for collection of waste from multiple residential customers, regardless of the method by which such services are contracted or arranged. An account for service arranged by a single property owner for collection of solid waste from multiple locations owned by that property owner shall not constitute a *group account*. **Designated for Group Accounts Collection include:** Aluminum and steel beverage, aerosol and food cans, newspaper (including all inserts), magazines, catalogs, junk mail, glass bottles and jars, and all plastic bottles and jars with opening smaller than the base – check for the neck. **Mandatory collection effective July 1, 2006: corrugated cardboard, brown paper bags, and paperboard.**

*Commercial customers* means any premises utilizing collection service where a commercial, industrial or institutional enterprise is carried on, including, without limitation, retail establishments, restaurants, hospitals, schools, day care centers, office buildings, nursing homes, clubs, churches and public facilities. *Recyclable Materials Designated for Commercial/Industrial Customer Collection are:* Newspaper (including all inserts), corrugated cardboard, office paper, junk mail, magazines and catalogs, aluminum and steel beverage, aerosol and food cans, glass jars and bottles, and all plastic bottles and jars with opening smaller than the base – check for the neck. **Mandatory collection effective July 1, 2006: brown paper bags and paperboard.**
