# Front Range Village Public Improvement Fee

## General Information

The Public Improvement Fee (PIF) is a fee and should not be confused with a tax. The PIF is considered part of the purchase price and is subject to the City of Fort Collins sales tax. The PIF is collected to be used on public improvements inside the Front Range Village. The City of Fort Collins collects the PIF from the retailers and remits it to the developer.

The PIF at the Front Range Village is 0.75% on all taxable transactions (except at Lowes and Target where the rate is 0.625%). Those items exempt from the City of Fort Collins sales tax and food for home consumption are also exempt from the PIF. As a reminder the PIF is a fee and is subject to the City of Fort Collins sales tax.

## Confidentiality

All financial information supplied to the City of Fort Collins is confidential. However, Front Range Retail Company, LLC and its Trustee are authorized to obtain financial information from the City as outlined in the Tenant Lease and Real Estate Agreements. Every tenant who is subject to the PIF collection obligation will be required to sign a Form of Waiver of Confidentiality. Financial information will not be shared or discussed with anyone that is not authorized to do so.

## Disclosure

It is required to inform customers about the PIF in the following ways:

**Advertising:** All advertising is to indicate that advertised prices are subject to state and local taxes, as well as all fees.

**Register:** Permanently place a placard at each register to notify all customers of the PIF.

All placards must read:

*“Customers are hereby notified that this store is located in an area subject to a Public Improvement Fee (PIF). The PIF of 0.75% will be added to the advertised price of all taxable sales transactions of tangible personal property and services. The PIF is a fee imposed by the Front Range Retail Company, LLC and collected by the City of Fort Collins on behalf of the Front Range Retail Company, LLC. The PIF is NOT a sales tax, but is part of the purchase price of all taxable sales transactions, and is subject to sales tax. For more information contact the City of Fort Collins at 970-221-6780.”*
