# Efficiency Works for Multi-Family

#### Available to Multi-family via Efficiency Works

- Free facility energy and water assessments
- All applicable business rebates/incentives
- All applicable home rebates/incentives
- Free technical and education assistance



#### Available to Multi-family outside of EW

- ClimateWise Partnership Program (Fort Collins only)
- Larimer County Conservation Corp direct install program (Larimer County only)











# Rebates for New and Existing Buildings

## Prescriptive Energy

- Lighting (LEDs, T12 to T8s, controls, redesigns)
- Cooling (High efficiency RTU, split, evaporative cooling and condensing, PTAC systems, new economizers and advanced RTU controls)
- Envelope (windows, insulation, cool roof)
- Office (task lighting, ES computers, plug loads controls)
- IT Thin client, server virtualization, etc.
- Lighting for new construction/major renovation
- VFDs up to \$120 per HP, 75 HP max

### **Custom Energy**

 Rebates based on \$0.10/kWh annual savings (chillers, evaporative coolers, compressed air, special controls, etc.)







# Rebates for New and Existing Buildings

Water Efficiency (Fort Collins Utilities only)

**Restrooms** – (Toilets and urinals)

**Food Service** – (Ice machines, steamers, dishwashers)

Irrigation - (controllers, nozzles/heads, audits)

Laundry – (commercial and residential grade equipment)

Custom – (car washes, ozone systems, etc.)

Rebates based on \$5,000 per acre foot annual savings and can be combined with energy savings for projects that save on both.

All energy and water rebates on one application







# Optimization Incentives for New and Existing Buildings

# Building Tune-ups (retrocommissioning)

Rebate is based on 100% of the cost of RCx study, implementation support and verification by RSP. Customer commits \$0.05 per sq. ft. for implementation of selected measures.

## Integrated Design Assistance Program

Performance base incentive for designing high performance commercial buildings. Applies to new construction and major renovation projects in Fort Collins - for now.

Requires separate applications.

# Larimer County Conservation Corp Program

A FREE direct installation of energy and water efficiency upgrades for single and multi-family residents. Priority is lower income but program is not limited to low income – there are no income qualifications.

Includes: energy efficient light bulbs, programmable thermostats, power strips, clotheslines, smoke/carbon monoxide detectors, shower heads and timers, faucet aerators and toilets.
