## Commercial Clothes Washer: Up to \$250 Rebate per Machine.

Clothes washer must be a 2011 ENERGY STAR® qualified commercial appliance. For a current list, see [energystar.gov](http://energystar.gov).

## Program Rules.

- ✓ Appliance(s) must be qualifying models, installed at a Fort Collins Utilities commercial water service address, and purchased on or after January 1, 2011.
- ✓ An itemized copy of the invoice/receipt must include manufacturer, model number, purchase price and date of purchase.
- ✓ Utilities reserves the right to verify the purchase, installation location and use of any appliance for which a rebate is requested.
- ✓ Rebate form must be submitted within 60 days of purchase of unit(s). For purchases prior to August 1, forms may be submitted through October 31, 2011.
- ✓ Rebates on delinquent accounts will not be processed until account is paid in full and will be denied if full payment on account is received after program funds are depleted or after application submittal deadline.
- ✓ Rebate program is subject to available funds.
- ✓ Limit of \$5,000 per account per calendar year for all commercial water rebates.

## Steps to Receive Your Rebate.

1. For rebates of \$1,000 or more, pre-approval is required (*see below*).
2. Purchase and install qualified appliances according to program rules.
3. Return completed application form and copy of your invoice/receipt to:

4. Allow six to eight weeks for bill credit processing.

**For a rebate of \$1,000 or greater:**  
Pre-approval is required. Complete this form with model names and numbers, quantities of equipment to be installed and itemized list of costs. Submit to above address for approval. A post-installation site visit also is required. You will be contacted for scheduling.
