Program Rules.

- Toilets must be WaterSense labeled models. View current list at epa.gov/watersense.
- Toilets must be for residential use at a Fort Collins Utilities water service address.
- Toilets must be purchased on or after Feb. 20, 2010.
- Limit of two toilets per address.
- New homes and new construction are not eligible.
- A copy of the receipt must include model number, purchase price and date of purchase.
- For additional rebate, recycling must be verified on application or by voucher.
- Fort Collins Utilities reserves the right to verify the purchase and installation location of any toilet for which a rebate is requested.
- Rebate program is subject to available funds.
- Allow four to six weeks for bill credit processing.

1. Purchase and install qualified toilets according to program rules.
2. Obtain toilet recycling verification.
3. Return completed application form (including signed affidavit on back), copy of your sales receipt and recycling verification to:

Toilet Recycling.

Toilet recycling is free if you remove the seat cover and all metal or plastic parts. ReSource will charge a \$5 fee to remove non-porcelain parts. The Streets Facility will not accept toilets if parts are not removed.

Affidavit - Restrictions on Public Benefits

I _____, swear or affirm under penalty of perjury under the laws of the State of Colorado that (check one):

- I am not a United States citizen but I am lawfully present in the United States pursuant to Federal law.

I understand that this sworn statement is required by law because I have applied for a public benefit. I understand that state law requires me to provide proof that I am lawfully present in the United States when asked as well as submission of a secure and verifiable document. I may also be required to provide proof of lawful presence. I further acknowledge that making a false, fictitious, or fraudulent statement or representation in this sworn affidavit is punishable under the criminal laws of Colorado as perjury in the second degree under Colorado Revised Statute 18-8-503 and it shall constitute a separate criminal offense each time a public benefit is fraudulently received.
