- Agriculture
 - Dan, Meghan, and Boris met
 - Focused on communication piece
 - Discussed business opt-out program
 - Keep it simple
 - Maintain annual inspection
 - Spoke about reaching out to Larimer County Agriculture Advisory Board
 - Waiting to hear back
- Public Outreach and Community Involvement
 - David and Katie met to discuss cooperation and alignment between City and County
 - Reviewed Public Engagement Plan from last year for improvements to be made
 - Business Opt Out
 - Emergency Call Center
