Application for On-Street Bicycle Parking Corral

Overview:

Bicycle corrals are grouped bike parking installations placed in the parking lane. The City of Fort Collins will prioritize on-street bike parking corrals where demand for bicycle parking is higher than can be accommodated on the sidewalk. Approximately 8-12 bikes can be parked in one car space, making bicycle corrals an efficient use of roadway space.

The City will pay for up to 6 on-street bicycle corrals per year. Bicycle rack design will be determined by the City of Fort Collins. Applications will be reviewed and installed according to the schedule below.

Criteria for Recommending and Approving Bicycle Corrals

Bicycle corrals will be recommended where short-term bicycle parking demand cannot be accommodated on the sidewalk and will be prioritized where:

- Demand is for five or more bicycle parking spaces
- Location does not create safety concerns

Bicycle Corrals will not be located within:

- Bus loading zone
- Fire hydrant zone
- Tow-away zones
- Designated accessible parking spaces

If not approved:

- Sidewalk racks will be installed where feasible
- Locations may be requested in the future if reasons for denial change.

Application Review and Installation Schedule:

Applications/requests will be accepted on an ongoing basis. Applications will be reviewed and bike parking will be installed twice per year, according to the schedule.
