



## 5. How long have you been employed at your primary job?





6. What is your hourly wage for your primary job?





## 7. Do you receive tips?







- 381 Even working full time with a minimum wage job makes it difficult/impossible to live without multiple sources of income or roommates, especially if you want even decent housing if you include other expenses. I know that at least at CSU, many student employees were denied raises due to lack of funds right before our former president was able to leave her job with a bonus of \$1.5 million.
- 384 I believe it must be raised as soon as possible. The cost of living has been rapidly increasing, from rent to gas to food, and it has outstripped the ability to live on approx \$12/hr. 640 Raising minimum wage helps those at the very bottom. What about those who are barely making above minimum wage? It's very demoralizing to be making \$16/hour and watch those around you go from \$12 to \$15 yet you don't get a raise. I'd like to know how this effects businesses and employee moral. My experience tells me that they tend to leave that position if possible or have lowered moral which leads to lower efficiency.

- 643 We need to balance the ratio of rental payments and the income! One third of my income cannot be calculated into for my rent!!!! I could get a second job but with my full time retail job my life and hours are dedicated to them meaning less flexibility that other employee would not hire me!
- 645 We need more money to live in this town!
- 646 Artificial wage growth causes the price of goods and services to rise.
- 652 Fort Collins must raise its wages especially for hourly city jobs. Rent and all expenses are high and it is hard for people to stay above water. We are seeing more unhoused people and raising minimum wage to at least \$20/hour is a moral necessity to keep people in their homes and safe.
- 655 Think about the small business owners and how this will impact them. The higher the minimum wage, the more expensive food, products, and services will become thereby impacting all families. Does the \$2.44/hour increase help or hurt families as businesses will have to increase their prices to cover this?
- 660 Raising min. wage will end up raising all costs by an equivalent amount, while due to inflation I still think it is a good idea, it won't "fix" anything
- 665 15 is equivalent to the current economy, it needs to be raised, thank you

666 You need to do this!

677	Minimum wage is criminally low and should be at least 18-22/hr. I shouldn't have to worry so much about paying bills and just getting by with the bare minimum and supporting my family when I work so hard for around 50 hours a week at 2 different manual labor jobs.
678	Minimum wage should be closer to \$20 than only \$15.
682	The state has already enacted a \$15 minimum wage. Why is Fort Collins wasting time duplicating what is already law?
692	Increase the minimum wage! Fort Collins needs to be a affordable for the people who live and work here.
695	There needs to be a standard set for part-time jobs to match the wages of someone working a full-time minimum wage job. For example: if minimum wage @ 40/hrs is \$15, minimum wage @ 20 hours should be \$30. Part time workers deserve dignity too.
699	I am working a good position which is funded by the NSF and provides for CSU. I am also a full time student and can barely pay my rent or eat food. I volunteer hours to provide for my community. I'm thinking of leaving the field of science because of how terrible the pay is, even in a quality job like mine. I would not like to, but it might not be feasible for me to continue this work. I'd like to live a life that contributes to society, but doesn't destroy my quality of life as well.
700	\$15 may sound like a decent hourly wage, but the truth is you would not be able to save for much less than a pair of shoes. How is the lack of affordable housing and high cost of living being factored in? It would be helpful to see a table of living expenses listed and how to pay for housing and utilities, a car and insurance, food and clothing with a \$15/hour job at say Custards Burgers. How does the city see this playing out? What is the desired outcome you hope to see for the community? What is the threshold for receiving city utilities reduced rates Does \$15/ per hour put us over the limit to receive these benefits?
701	Minimum wage should be bigger as housing and rent prices continue to raise. Living as a wage slave isn't rewarding as I never have expendable income to enjoy myself.
706	Minimum wage jobs are not meant to be a living wage, they are meant for those needing something to get started. It would hurt the ability of small businesses to get started and keep going - they are already barely getting by. Increasing minimum wage only increasing the expenses for everyone.

707	Minimum wage is for people starting out in the job force (example high school students). Old workers should be above the minimum wage and if you raise it they will not get an increase in wages. Cost of goods and services will go up again. Cost of living will be even more out of reach for people. Cost of goods and services will go up again. This is a bad idea.
710	I don't believe the government should set a minimum wage, that should be up to the business.
713	The cost of living here is too expensive to live on what minimum wage workers make; minimum wage could be \$20 and that would still barely be fair. It drives young talent out of the town and it starves the people working in service industries (and by extension those industries themselves, which largely serve the upper middle class). I'm a young professional who was born and raised in Fort Collins, and I love it here, but unless serious policy/economic changes alter the town's affordability and class diversity, I'm going to end up scattering to other cities like many of my generation who grew up here.
714	Thank you for starting this process and collecting this data! Fort Collins is getting too expensive to live in for people who work non-professional jobs here, which increases fossil fuels emissions, increases traffic, and decreases quality of life in many other ways. I hope we can increase the wage to help counterbalance this!
715	Fort Collins has gotten astronomically expensive and inflation is crazy. If we want to retain awesome people, we gotta make it at least 15 with scheduled regular increases.
717	I am in full support of raising the minimum wage in Fort Collins. I was born and raised here, and it has been a struggle watching the cost of living skyrocket in recent years, making it exponentially more difficult to afford living here on the type of wages most employers are offering. Most people I know have to work multiple jobs or stressful, exhausting hours just to be able to afford rent, let alone have any income left over for leisure to enjoy our beautiful state, or to plan for financial emergencies. I currently work full time (36-40hrs/week) at \$17.82/hr, after working mostly minimum wage range jobs (\$7.50/hr tips to \$14.50/hr), and this is the first time in my adult life that I have felt like my job pays me enough to afford my baseline expenses with a little wiggle room to not constantly be stressed about money. In my opinion, \$15/hr should be the absolute bare minimum wage across the board. Long time Coloradoans like myself have been struggling to remain in our home state due to stagnating wages, and as such, we are not able to feed into the economy and help Colorado grow in the ways we want and need. Raising the minimum wage will alleviate a lot of suffering and hardship, especially

minimum wage will alleviate a lot of suffering and hardship, especially among those residents who have been hit hardest by the pandemic and other global events.

- 722 It needs to be \$15 MINIMUM nationwide. Places with high living expenses like Fort Collins should consider raising it upwards to \$20 if they want us to have a chance at saving any money
- 724 I am not an advocate of raising the minimum wage. As the supply of workers tightens up, employers will raise their wages. But setting the wage higher than the market will bear leads to higher expenses for employers, who then have to pass their costs on to their customers. Fort Collins is already hard to afford. Increasing the minimum wage may appear to help for a while, but there will be fewer job openings as a result. Note also that the higher wages mean higher Social Security and other payroll taxes for employers, which will also raise expenses and contract the labor market. Please avoid interfering in the market!
- 728 We should raise the minimum wage to align with cost of living in our city. The supposed "labor shortages" during COVID show that trusting to supply and demand is inadequate for making sure employers are willing to adjust their business in order to pay competitive and living wages.
- 729 We are retired and I work part time for the city. They raised our wage due to difficulties in finding PT help. I appreciate the wage increase but if we didn't have retirement income we would not have a living income.
- 730 The market is already deciding the minimum wage near or above \$15, so the city doesn't need to adjust it up further than the state law that recently increased wages. The need for employees is driving wages to \$16-18 for most retailers already.
- 736 Businesses, especially bigger businesses, Big business and 10 stores are more than glad to keep their salaries little while or profits grow and grow and grow.
- 738 The cost of living here, especially in regards to housing, means we NEED an increase to minimum wages. Looking at rent costs, the bare minimum here should be \$23.75. That's based on the FHA guidelines that a MAXIMUM of 30% income should be spent on housing costs. This is actually a low-ball estimate because I only based it on the average rent rate for a 1 bed 1 bath and didn't include utilities with the FHA does include in their 30% guideline. No one can live in this city while working a full time job at the cities minimum wage.
- 739 I do not support a city-wide minimum wage. We would not be competitive with neighboring communities and a raising minimum wage would further inflation woes.

742	The market will dictate salary. Wage laws hasten to promote soft, workers and ethic. As a nurse, the market has dictated my salary. Not because a beautician wanted to justify such an insidious conversation. I am good at what I do and I am therefore compensated appropriately. The best places to work will be where the service is best for the consumer. The best workers will elicit the best salary. Not the other way around. Do you eat at places with poor service and food? Neither do I. Do you shop at stores with poor customer service? I suppose you do not. When the government gets out of the business of dictating market behavior, maybe we will have a chance at improving our experiences with stores that train, and retain, their best asset. The good employees that deserve what they're paid. Here's an idea: focus on homelessness instead of some idealistic propaganda.
746	\$15/hour is still far insufficient!
747	It should be raised
748	Raising the minimum raise would be pivotal in improving my work life balance as a university student and that would improve my mental health, physical health, and living conditions
749	The minimum wage needs to be at least \$15.00. Even that is hard to live on in Fort Collins, but \$12 is just a disgrace.
750	I would like to see all workers in our city receive a fair wage, especially considering the high cost of housing.
752	Minimum wage jobs have never been intended as lifelong jobs. They are not intended to be a way to buy a house, raise a family, etc. They are part time

intended to be a way to buy a house, raise a family, etc. They are part time jobs for earning a bit of spending money or extra money. People currently earning a bit more than minimum wage will not see pay increases if minimum wage is increased. Raising minimum wage will raise the price of everything making it more difficult for people with full time, adult jobs to live in Fort Collins.

- 753 Like I said? This would greatly impact people that are on SSDI.. It would greatly kill it, and people that get it, would either have to quit their job to keep SSDI, or loose SSDI all together and all the benefits that goes along with it. And it would also effect how much they pay in rent to!
- 755 Aim for \$25/hr, 15 is far too low to keep up with inflation and increasing cost of living
- 758 Businesses have already jacked up prices and this will make it worse. I don't see it as only a minimum wage problem, my salary is not going up (I make more than minimum but not a living wage) but everything else is. Haven't you noticed that every time minimum wage goes up, so do the prices on the menu at your local eatery? From businesses to landlords, they will jack up prices and people will still not be able to afford to live here.

765	It's great to see the city looking into it.
767	The relatively low pay levels at my workplace have made it difficult to hire and retain quality workers. We've been running short-staffed for more than six months, and many shifts go uncovered. We operate with perhaps 20% fewer workers than we did pre-pandemic, and it is becoming unsustainable.
769	A decent Minimum wage would mean people who work basic service or entry-level jobs would be able to stay here and provide those services to the community. It could also reduce crime as people are not as desperate for money (and happier people are less motivated for crime).
770	I fully support minimum wage increasing especially as the city becomes harder to live in with the rise of inflation and rise of cost of living
771	While the change would not impact me directly, I know an increase would enable many residents to feel less financial pressure. At the bare minimum the city should be keeping up with inflation to help combat the rising cost of living. Going above and beyond that is a necessity for keeping the community strong and sustainable for everyone
780	Minimum wage is the floor. We need a living wage
783	I support raising the minimum wage to help our overall community and spread income to those who need it most. The cost of living and cost of housing has increased incredibly in Fort Collins, minimum wage hasn't kept up
784	Raising a minimum wage for unskilled labor further decreases the incentives to work skilled positions. All that will happen is skilled labor will take their services to areas with lower cost of living
788	\$15 would have been great 10 years ago when people were asking for it. With all this time wasted, you're now considering out-dated numbers. With the raise in inflation, we should now be talking about at least \$20/hr for minimum wage at this point. Please, get it together, people are out here struggling everywhere.
790	The minimum wage is too low and must be raised. \$15 an hour is still not enough.

797	Everytime wages go up I get more money but cost of living goes up about the same plus taxes keep getting more and next year I have to pay into a time off fund for no reason as my employer always works with us if we need time off and are reliable workers. I'd rather taxes were lower than raise my wages
798	The minimum wage should be raised, especially given the local cost of living. It would not affect me, but I feel strongly about folks being allowed at least a living wage.
800	Even at \$43,000 a year, I could probably not afford current market rent and other necessary expenses on my own. Minimum wage must be raised to help people keep up with rising rent and other expenses.
801	The labor market will determine what the minimum wage will be. No need to legislate it that would be too much interference in private enterprise.
802	Absolutely nessesary, to bring the wage up general cost of living esp housing makes it impossible to survive on current min wage

815	Fully support it!
816	With the cost of living here, I think it should be at least \$20/hour. Target starts at \$15
818	With the huge increase in cost of housing over the last year or two, we absolutely should raise the minimum wage to \$15/hr. I make much more than that and money is still tight living here with the high cost of rent.

819	Minimum wage is for entry level jobs. No one should be making minimum wage after working at a place for a year or more. If they do, they need to accept that the place they work is taking advantage or leave and go to another company. Everyone is paying more than minimum wage. Raising minimum wage will only increase the pricing of everything. Anyone who makes more than minimum wage will in turn make less if minimum wage is increased.
822	I am fully supportive of raising the minimum wage, even though I am salaried and this doesn't directly effect my income.

Even with being paid well, I feel like I need to make significantly more to be able to save for my future goals like adopting children, owning a home of some sort, etc. If I feel this way, I imagine my neighbors feel it even more. Another way to alleviate this would be to focus on affordable, nice housing for all. But, raising the minimum wage would definitely be a helpful start!!
826	This is something that is desperately needed, especially in this area of the country, where wages do not keep up with the cost of living.
827	The real minimum wage is zero. I will vote against any measure and any politician who supports the minimum wage as it is a recipe for unemployment. The only reason I was able to work my way up is because when I started working (9ish years ago) I started at \$8. That opportunity wouldn't exist for me today if the minimum wage was any higher.
830	I think it is a good idea to raise minimum wage.
831	Even though it wouldn't affect my day to day life, I strongly support a worker's right to make a living wage.
836	It's ridiculous to think that someone could live in this city while making minimum wage. We can do better for the folks in our lowest income categories.
839	I work in the nonprofit sector and see folks struggling to make ends meet every single day. While a \$15 min wage is a great improvement, I'm very concerned that the cost of living is increasing so much faster than wages that we're going to lose good folks who are a critical part of our community. I know businesses will be worried about the increase, but as a community we have to decide what our priorities are.

841	It is impossible to live on minimum wage in Fort Collins. The only way I am getting by is because I also have Social Security. Even so, I am still in the red, not breaking even, because of insurance and pharmaceutical costs, and the general cost of living. It is insulting, degrading, and humiliating to be unable to support oneself while working very hard at a difficult job and living in a country that has immense wealth. We ALL deserve to be able to support ourselves on minimum wage payments. Fort Collins needs to help us increase our income so we can still afford to live in this great city. By the way, I have never been so poorly paid in 60 years of working as I am right now, due to Covid and how low the pay is in this city!
842	Terrible idea. Basic economics teaches a wage is voluntary trade. Chipotle offers \$12 an hour and if I want more, I find another job or get more skills. If too many people refuse to work, the market dictates low supply of workers so chipotle now needs to raise their wage. Forcing a higher wage on employers has unintended consequences of lower hours due to increased wage, reduced benefits, higher prices for food/items they produce to recoup costs, lay offs, etc. let the market dictates a "fair" wage and if a company is lowballing wages, people will quit or leave forcing a change.

863	15 an hour would help. But they also need to raise amounts you can make to qualify for certain benefits ( day care assistance, housing assistance, food stamps, and medicaid) otherwise it can actually put people in a worse situation making it hard for them to work! Especially single parents!
865	The average people of FoCo can't afford to live here despite wanting to live here! I'm concerned about small business owners not being able to afford paying the wage increase, however if at least the big employers can, I think it would be great start to help residents stay in the area and ensuring a more diverse pop.
868	It would benefit the majority of the population giving some families and individuals the opportunity to actually have a manageable life that isn't work 24/7.
872	Though I make more than minimum wage as a social worker, I know in my work with my clients that an increase in minimum wage would be very helpful. I know people who are single-parents, doing the absolute best they can and working full-time at a job; making \$13/hour, \$1900/month for four people. That is not nearly enough, and though they are pursuing other options, they are currently barely making it. An increase in minimum wage would help the situation, as long as government assistance is adjusted to match.
873	New city employees are being hired at higher wages, making older ones less likely to stay
878	Prices are so high and the people can't live off what we're making now. Prices keep raising and wages are stagnant. People are being pushed further in to poverty
879	It would greatly benefit the larger community. I would not be able to live in Fort Collins if it wasn't for the fact that my fiance makes double what I do and is able to pay the bills on his income alone. It is unbelievable that anyone would be able to live securely here making less than \$20/hour.
881	We need to raise the minimum wage nation wide, but especially locally, where we have the power to do so. Given the dire economic, environmental and political situation currently, this small change would provide a great deal of help to people most affected.
882	Raising the minimum wage would be more effective if accompanied by a rent cap; I've lived in Fort Collins for a decade and my rent has always increased faster than my annual income.

884	\$15/hour gets a lot attention, but it doesn't seem to have any relevance. Most every job I see posted offers more than \$15/hour. I'm very concerned, however, that setting a minimum higher than the statewide amount puts entry-level jobs in ever greater jeopardy. And with acrecession looming, it seems like a really bad idea to further disrupt the job market.
885	How about putting the breaks on skyrocketing housing costs. Minimum wage increases are really quite useless unless people can actually buy/afford more. A minimum wage increase to \$15 doesn't even keep up with how crazy the cost of living has become in Fort Collins.

891	Minimum wage in the country as a whole is too low, but it is particularly a problem in a place like Fort Collins with such a high level of expense. Raising minimum wage is an absolute necessity for the city to remain a viable place to live for lower income individuals
895	\$15 minimum wage isn't enough anymore, it does not keep up with inflation or cost of living here! Please consider helping those of us who love this city afford to stay here!
896	The cost of living is increasing and we are headed into another economic crisis, it would be irresponsible not to increase the minimum wage. Thank you.

- 900 With cost of living increasing every year, minimum wage should match that. It's what makes living here do-able for people of all ages incomes (not just the wealthy).
- 901 Another minimum wage increase will cause cost of living to also increase. These two are ALWAYS linked and unavoidably go hand in hand. It is getting unmanageable to continue raising cost of living at such high rates. Minimum wage is meant for teenagers who still live at home. Minimum wage is NOT meant to be a "living wage." When we keep raising it, we are creating situations where adults are depending on it because it is harder and harder to step up into better positions and better pay. It makes it harder to take unpaid time off (or be able to afford to reduce work hours) to seek further education in order to get better paying jobs. This creates inequity and deepens socioeconomic gaps. Please STOP raising minimum wage!!! It sounds like a good idea, but the reality of the domino effect it puts into place is not good for our town's overall economy. Fort Collins is creating a town that only the homeless and upper class can afford to live in. The cost of living continually going up in such high increments is pricing out the middle class. This is not equitable.
- 902 Our current minimum is laughable given inflation. More money in the pockets of workers helps everyone - more money to spend on other items which increases the revenue of a wide variety of businesses, increases quality of life by not living paycheck to paycheck, etc. Please increase it!
- 907 Fort Collins Minimum Wage NEEDS to be \$15 to be competitive. We have many staff shortages because the turnover rate of people leaving for higher paying jobs. This is a good place to work but for many it doesn't matter when it doesn't pay a true living wage.
- 911 It's a good idea, especially with the major increases to the cost of living in the Choice City. We need to keep people to continue thriving.
- 913 15 isn't even enough. Please remove the rule that only 3 unrelated people can live with each other. It's contributing to awful housing options for students. It's so pricey here. Help us
- 920 I live in an apartment that causes asthma because I can't afford to move into another apartment. I am literally losing my health and future wellbeing because I am not paid a living wage. My employer is UCHealth and Kevin Unger (PVHS CEO) tells me the 3% increase in wage that I receive each year is a raise but the CPI rises 4-6% each year in Fort Collins. A raise in minimum wage would protect me because my income is based off 120% of the minimum wage. However, the city could best help me by changing the zoning in Fort Collins to allow for medium and high density around Old Town and the College Avenue corridor. This would help reduce the skyrocketing rents.

923	Minimum wage was never intended to be a living wage. There needs to be a starting/youth wage level for people entering the work force. Hard work & learning more should lead to increases in pay. My kids have not been able to get full time jobs due to the current level of minimum wage & the fact that full time would require benefits to kick in.

930	I'm in favor of a living wage We try to support businesses that we know are or are trying to pay a living wage. I also understand that experiments to pay wait staff a living wage and do away with tips have not gone well (when individual restaurants do this), but I'm in favor of that, too - the tipping custom is bogus.
938	It's good for the economy and good for Fort Collins to be a leader. With its higher than average cost of living, we should have higher than average minimum wage. It isn't right for wealthier people to rely on services provided by underpaid employees.
939	I was lucky to get into the industry I am in and get paid much more than \$15 an hour. However, many of my very educated friends who are therapists, teachers, child care workers, etc. are NOT thriving, even at \$15 an hour. With inflation having trended upward drastically since the 90s, \$15 is still poverty wages. \$15 is honestly slave wages, despite our young adults being more educated than ever before in this country's history. AND very often there are NO benefits! If Fort Collins really wants to help people, make the minimum wage at least \$25 and offer community options for Healthcare that aren't dependent on employment. Or push our state reps to give the citizens of Colorado the option of either private insurance OR a single payer system for medical like they're doing in California. As a long-time businesswoman myself, what I would say to businesses that claim they cannot afford to pay their employees a thriving wage then you do not deserve to be in business. If you can't have a business without exploiting people, your business deserves to fail. Please consider with sincerity that a wage higher than \$15/hr would be more beneficial for our citizens and give them a chance to thrive, not just work to barely survive.

We need a minimum wage of \$30, or rent control that doesn't allow greedy landlords and corporate property managers to exploit the working class. We need to meet the needs of people, not the needs of profit if we want a happier city.

1387	15 is the bare minimum, 20/hr should be the new minimum!!!
1389	it should be raised.
1391	I have been trying to move out of my parents for 3 years, always having a job and I've never made a livable wage to live here
1397	Fort Collins and surrounding areas are outrageously expensive. People like myself, my husband and our roomate who all are educated and work in our fields of study can barely afford to live here. Giving people 15 an hour won't allow people to thrivebut it'll at least make sure people are more likely to be able to feed themselves and have shelter. Saying that unskilled workers don't deserve a living wageaka a wage that allows them to both eat and have shelteraka basicsis a travesty. This city needs to do better. Soon people who have lives here their whole lives will be priced out.
1400	\$15 dollars is no longer enough (we needed that 10 years ago) however it would ease the financial struggles of many people in our community who are being priced out of their family homes and neighborhoods. People will spend more money in our local economy if they have it to give.
1401	With housing costs on the rise we need higher wages or affordable housing. Or BOTH!
1408	Minimum wage in Fort Collins is not a livable wage. Even with 15\$/hr I still need a second job to make sure my expenses are paid. The housing market is the main issue I face. To work in on job at full time hours 20\$/hr would be need to cover expenses.
1410	I do not want to be priced out of living in Fort Collins. I have been living here for 10 years and raising the minimum wage would help exponentially.
1412	My roommates would be positively impacted by increased minimum wage, they could shoulder more house related expenses

1417	Minimum wage was always meant to be a living wage. If you want quality of life to keep up with inflation, raising the minimum wage is a necessity.
1418	My friends would be less inclined to have multiple jobs with a raised minimum wage. this would greatly improved their mental health as well as well-being in our great time which they currently have no time to enjoy since they're so busy with work just to pay rent every month.
1423	Higher wages would be nice but inflation is already bad as it is I wouldn't want it getting worse.
1424	Consider ending you plus two. It makes no sense in many households and prevents affordable rent for students.
1429	\$15/hour is on the low end of a livable wage in Fort Collins as-is, only reason I'm able to get by right now is due to help from my parents. If you really want to create a long-lasting solution and not hsve to revisit this issue every few years, I would strongly recommend including language that includes automatic annual raises to the minimum wage consumate with the rate of inflation.

1431 My organization recently restructured how they pay folks in my position. I (and everyone in my position) functionally received a raise that brought me from \$18/hr to \$24/hr. Aside from the fact that this fundamentally changed my family's life I say this to contextualize my survey answers. I work with homeless adults as a case manager. My primary job is to help them pursue their goals with the ultimate goal of no longer being homeless. I do this by helping clients acquire benefits, livable wages, and housing. A substantial portion of my clients work multiple full and/or part time jobs and yet they remain my clients until they get lucky enough to acquire a voucher or some form of affordable housing. I comfortably wager that the many of the folks making and serving your food, cleaning your bathrooms, driving your rideshare, and bagging your groceries have an appointment with me or someone like me The data to show that both rent and worker productivity vastly outpaces pay is fairly overwhelming. The data to show that increases to minimum wage are not the primary source of rising prices hamstrings the argument that doing so will be felt by the consumer. Naturally a minimum wage raise is not the solution to homelessness and poverty. That solution comes in package form. The data and road map for that is well known by the folks working with individuals experiencing homelessness. I am fortunate to work in a city that is familiar with the solutions to homelessness and put resources to that end. Still, the minimum wage is a piece of that puzzle. Even though I don't benefit from a raise minimum wage directly I am still passionate about it. First, we don't have to struggle with something to see why it matters. Second, a raised minimum wage would cause an absolute paradigm shift in my job and I am certain many of my clients would finally be able to afford to live. Third, in a community what is good for one can be good for all. I and my neighbors benefit when others make livable wages. The health of the community is affected in systemic, rippling, and far reaching ways. We benefit when our community and its members benefit. Even if I did not work in homelessness I would support ideas that have been demonstrated to improve lives and communities. A heart without brains is dead. Compassion without intelligence is useless at best and, more often, it is damaging. A raised minimum wage - ideally a livable minimum wage - is an objectively verified and effective form of building a more humane world. Heart aside. Pure, cool, and calculating logic would call for a raised minimum wage. A raised minimum wage takes people out of poverty. It jumps the gap between abject poverty with benefits and middle poverty where you don't qualify for benefits. It creates stronger and more resilient communities. It reduces the number of high utilizers with whom a City interacts. It reduces crime and antisocial behavior. People move into and buy things from towns where you're able to breathe between paychecks. They start businesses and raise kids that don't leave after college. Folks that work in my industry sleep easier knowing homelessness can end for their clients; specific people with real stories. Cities with livable wages and the people that reside in them thrive. Fort Collins is far above its peers in its commitment to building a healthy, livable, and vibrant community for all its members. A raised minimum wage is an intelligent, humane, and effective method of following through on that commitment.

1432 Even with both adults in our home working above the minimum wage (one 50 hours/week and one a student who works part time) we barely make it each month after bills and childcare. There are other community members who are making even less than we are, getting paid at the current minimum wage. Truly, how are they surviving each month? The current minimum wage is not livable. 1434 With inflation rising everywhere else, it would be nice to have alike companies come together to make sure their employees will have a more stable household income. 1438 We can lead the way, like Portland. Should do it, 1439 The minimum rent price for most one-bed apartments is over \$1100.00 a month. To even qualify for that you need to be making over \$20 an hour as a single person. Not likely since the majority of working adults work for minimum wage. According to the department of labor, in 2017 58% of working adults made the minimum wage. A gallon of gas right now is almost \$5.00. for a person making \$12 an hour, it costs more to probably drive to work than the money they make while working. Since we all know Fort Collins doesn't have a great bus system. I believe we should raise the minimum wage to over \$20.00 an hour. Working in homeless resources for over three years I see so many people struggle with housing costs and a tiny minimum wage. 1441 I think it would help a lot. But how would it impact employers? It might impact youth because people would hire older workers instead of young kids, who may not know how to work. It is also a large jump all at once. Please help lower rent and house prices in some way. I have been reluctant to apply for jobs that pay minimum wage, in spite of needing them, because I can make more working freelance jobs. My schedule is more flexible with those, too. 1442 would not make since the State minimum wage goes up by standard of living each year already. I think a city Minimum wage is stupid. 1445 Current inflation adds to the necessity of this, plus long overdue in keeping up overall economically. The so called 1% have taken quite good care of themselves to the detriment of the 90%, etc. Time for that cycle to change.... The people that are forced to work minimum wage jobs are barely getting by 1448 and sometimes need multiple jobs to survive. They are the people in society that need extra cash the most. The detriment to this is that employers will no want to take the hit and will do what they can to transfer the cost to tipped workers or consumers. But I dont think that is a valid reason to limit minimum wage workers because again, they need to get by. As a result of an increase, maybe people will not have to work an extra job and have extra time for their family or education.

1454	Pay people a livable wage
1456	I think it's critically important to raise the minimum wage in Fort Collins. Fort Collins has an extremely high cost of living. CSU's own Regional Economic Development Institute published a report in June finding that 28% of the Fort Collins workforce cannot afford to live in the city. This is unacceptable and is strong grounds to raise the minimum wage.
1464	The "new normal" is depressing. Renting in the City is incredibly difficult. My landlord increased rent by \$400/month so I am forced to move this August. My situation is not as bad as others because I am juggling multiple gigs. But wow is life painfully difficult if you're earning the current minimum wage. It's really just awful that the Feds haven't done anything in so long and forced CO and Fort Collins to react. Please do something.
1465	l support a min. wage of at least \$18/hr
1470	It won't impact me, but I worked a food service job here in town from 2015- 2021. That job sucked the life out of me, and I was not adequately paid for it, despite working there full time for several years. \$15 would've really helped me out when I was working there, and I can imagine how much this will help those in that current situation.
1474	An increase in the minimum wage is needed for employees earning less that \$25 hour. Inflation and increases in rents have decreased the buying power of the minimum wage. Folks have a very difficult time living in Ft. Collins even with two full-time earners who make minimum wage. Those of us who earn more need to pay more for our services in the city.
1475	Livable wage in Fort Collins is around \$26/hour. Raising it to \$15 is better than nothing but I would still consider nothing more than the bare minimum.
1478	This would generate important benefits for our community including an increase in the labor force participation, decreasing the labor shortage.
1479	Living costs are extremely high here. Given the u 2 housing ordinance and other factors, it is very hard to pay rent and other expenses and then have savings, if you are even able to do those things. Raising minimum wage is crucial to work towards living wages for people here.
1480	A \$15.00 minimum wage at 40 hours per week does not amount to the ability to rent in Fort Collins. 2 workers at \$15.00 per hour and 40 hours per week requires half the combined income for rent within Fort Collins.
1481	Our cost of living is so high ! People can't afford to pay rent and feed their families . I'm definitely in support of a higher minimum wage.

- 1513Though I am a well paid salaried employee I strongly support \$15.00 an hour<br/>for other hourly employees.
- 1519 This survey is obviously skewed to hourly workers and does a very poor job in asking specific questions certain types of employees to gain useful information. I am a salaried worker, with great benefits and I work 60 hours a week. I am paid fairly and a \$15 minimum wage would not affect me, but I am worried my answers are going to be lumped into some sort of category that misrepresents the whole pictures because the questionnaire is poorly designed.
- 1530 I believe the minimum wage should be raised to at least \$15/hr if not more. People need to be able to afford to live here and raising the minimum wage is a step in the right direction.
- 1531 Increasing the minimum wage would not affect me, however I wholeheartedly support increasing it nonetheless
- 1532 The cost of living in Fort Collins has grown increasingly inaccessible in the last few years. Raising the minimum wage makes it easier for more people to build a comfortable life for themselves here. I truly believe that this is a "rising tide lifts all boats situation." Increasing the minimum wage encourages business to offer better benefits and more competitive wages to attract quality candidates, whether it's at a tech company or a local restaurant. Better wages and benefits insulate workers from cost of living increases and improves their standard of living.
- 1535 I think raising the minimum wage will help everyone across the board. I hear a lot of folks complaining about things such as grocery stores not having in person checkout stations available (self checkout can be difficult for folks with disabilities, young kids, large cart orders, the elderly, people with injuries) so if we paid folks more, I think grocers would have less turnaround and maybe more employees available to help even such a simple singular part of our community experience such as grocery shopping. I don't blame folks for not wanting to be at the front of grocery stores in general, but especially at current wages. So for folks who make more than minimum wage, this increase will still make your quality of life better. We as a society can stop complaining that nobody is working/wants to work and start paying people a living wage to entice them to work the jobs most of the folks complaining would never want to do.
- 1543 I would like to see targeted raises in specific jobs/fields rather than an overall increase in minimum wage. For example, early childcare/preschool workers in Larimer County make between \$12-\$15/hour, while you can make \$20/hour on the night shift stacking cans at Walmart. Do we really value that work over the safety of our children? Specifically, education and caretaking fields need wage increases.

1544	Minimum wage jobs are not meant to allow someone to support a family. They are for high school and college students. Anything over \$12 minimum wage is absolutely ridiculous. I worked as an EMT for nine years for less than \$15 hour. Address the real problem and pay workers that are trained to save lives more money and fast food workers less. 
also a problem with businesses not paying their employees a livable wage.






