Probing questions in orange

1. When you imagine a sustainable Fort Collins in 2030, what comes to mind?
 - a. What do you think we need to have in place if Fort Collins is going to be strong generations from now?

2. What would your business or organization look like in a sustainable Fort Collins?
 - a. Does your business have goals relating to climate change or sustainability (organizational or industry specific)?
 - b. What are your organization priorities in the next 10 years?

3. What are the things you would need to get there?
 - a. What are your organization's biggest barriers to achieving these goals?
 - b. Do you currently have resources for achieving your sustainability goals? What resources are still missing?

4. Of the things you would need to get there, what do you envision the City's role to support you?
 - a. Encourage them to be specific ex: Connection to programs, recognition, networking, technical support, Connection to contractors, education and training, connecting to citywide goals (reporting i.e. tracking data), etc.

5. Thinking about Fort Collins and our region, what potential climate change impacts are you most concerned about for your organization?
 - a. What do you need as an organization to be resilient to those impacts or hazards?
