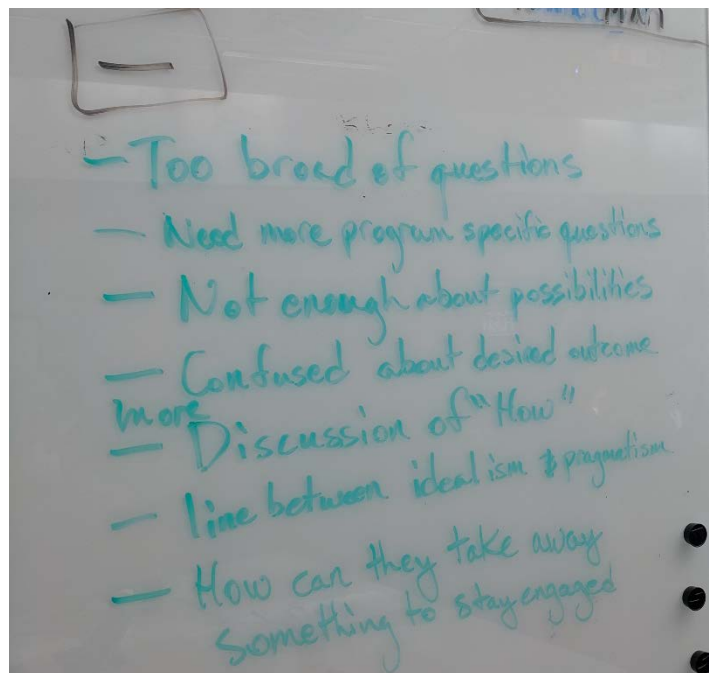
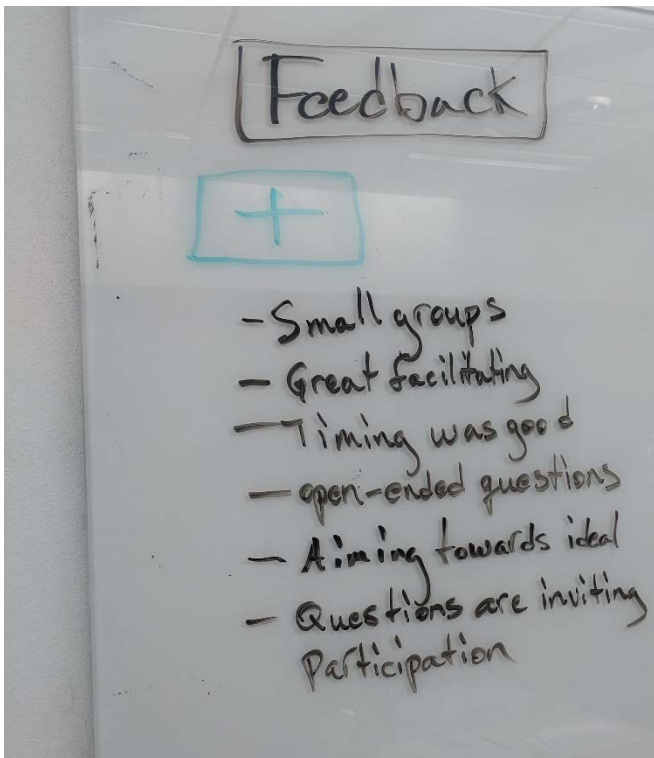
- Attendees participated in the Community Conversation as a regular community member. Ideas and feedback were captured by table facilitators.
- Feedback on the 5 community questions and overall process
  - Positives
    - Small groups
    - Good facilitation
    - Amount of time was good
    - Open-ended questions
    - Aiming toward the ideal
    - Questions are inviting for participation
    - Like the structure of broad questions with facilitators having probing questions to go deeper
  - Concerns or would like more of
    - Too broad questions
    - Line between idealism and pragmatism
    - Discussion of “how”
    - More program-specific questions (might be off-putting to some participants if too specific)  
A. This will be addressed more in phase 2, goal here is to level-set and bring along people who have been less involved with this topic, listen for topics that might not have been brought up yet
    - Not much about possibilities
    - Unclear desired outcomes – what will be done with this
    - What is takeaway for people to stay involved in the process as an active participant
- Feedback on potential business questions
  - Missing question – what are you most concerned about (similar to question 3 in the community questions)
  - Add question or facilitator prompt: What resource are you most concerned about for your future (price of energy, water, timber availability)?
  - What is meant by business, and why are they being prioritized? Include other types of organizations such as non-profit organizations, city, CSU. May want to parse out results depending on “demographics” of organizations.  
A. More than half of GHG inventory is business, need to expand beyond residents to include businesses. Want to harness the business perspectives.
  - “Sustainable FC” is very broad.
  - On #4, expand/add question about how your business/org can partner with the City in achieving these goals, e.g., how can your business partner with the community to achieve the goals?
  - On #4, keep in mind it’s not just “give me a subsidy for my business/org”
  - Is the purpose to begin engagement or solicit concerns?  
A. Two purposes – getting some specifics for how the City could take action for the ClimateWise program, as well as more broadly understanding the business community priorities for our climate future.
  - Note: expect that these questions could evolve as trying to use.
  - Written comments:
    - What does your business do now to contribute to climate action? What can your business do in the future?
    - Include business and organizations in the title
    - Include the diversity of types of businesses in engagement, size, focus, etc.

- Is there a risk of losing interest by starting so broad? Will some folks be turned off by it being "basic"?
