About this Report

As part of the effort to provide residents the opportunity to rate the quality of life in Fort Collins and their satisfaction with community amenities and their local government, the City conducted a scientific survey of 3,800 households within city boundaries. Mailed surveys were sent to randomly selected households in April 2022 and data were collected through May 27, 2022. The survey invitations also contained a URL where the survey could be completed online on Polco in English or Spanish. After the official data collection period was underway (see the report, *The Fort Collins Community Survey Report 2022*), the City of Fort Collins made available a web-based survey to its residents through a link on the City's website and other various communication avenues. Residents were able to complete the survey for two weeks in May 2022 and 185 residents responded. This report contains the results of this open participation administration of the web-based survey.

These data were not collected through a random sample and it is unknown who in the community was aware of link on the City's website; therefore, a level of confidence in the representativeness of the sample cannot be estimated. However, to reduce bias where possible, these data were weighted to match the demographic characteristics of the 2010 Census and 2017 American Community Survey estimates for adults in the City of Fort Collins. The primary objective of weighting survey data is to make the survey sample reflective of the larger population of the community. Survey results were weighted using the population norms to reflect the appropriate percent of those residents in the city. The variables used for weighting the household respondent data were gender, age, housing unit type (attached or detached), housing tenure (rent or own), and area of residence. No adjustments were made for design effects. The results of the weighting scheme are presented in the table on the following page.

Q18: Why is it important to you, or the community overall, for the City to focus on the area you mentioned?

- A lack of affordable housing makes it difficult for low- and middle-income earners to live and work within the city.
- A livable environment is the foundation upon which all other community functions rely and the City is in the best position to provide systemic change and actionable guidance for individuals to constructively participate in solutions. Choosing only one item is very restrictive, as providing for good government, accessible/affordable/inclusive housing, and ensuring that we have the resources to support and maintain the quality of the community infrastructure we already have (parks, cultural resources, etc.) are also critically important. But choosing just one brings me back to the environment as the groundwork for all others.

- All the red lights increase emissions, stress, MVAs, and diminish economic activity
- As a minority in noco I see no representation in our city government. Lots of q and blue loves flags in many neighborhoods make us feel unwelcome
- Badly managed growth causes problems in all areas mentioned above.
- Because good, intelligent, hard working commjnity members are choosing to leave the choice city of Fort Collins because of the incompetence and arrogance of some of the city staff and their unproductive processes.
- Because I can no longer afford to live in the community I grew up in...no places available for seniors to live...it's really very horrible how the city has not effectively managed the housing crisis.
- Because I see alot of people in their 60 and older that can't stand very well and would like a place to sit, when I am on the bus and their is no more seats I will stand and give someone my seat that I was in.
- Because I'm outside breathing the air all day
- Because nobody wants mandatory water restrictions! Encourage citizens to remove turf in their yards, within reason, and especially in the city's parkway areas. We send more water into the streets trying to water turf in parkways that never looks good anyway because our soil is so poor and the tree roots take up so much of the small area available to them.
- Because of you do it wrong you'll waste money making the problem worse
- Because people like me are being priced out and do not have a future in FoCo, it's turning into a wealthy mountain town that can't support the people that make the town what it is
- Because people won't move here/will leave if they can't afford a place to live.
- Because pollution and in particular air pollution kills thousands every year, reduces the quality of life, destroys our ability to enjoy the outdoors and compromises the health of our children. Not to mention the incalculable damage to plants and wild animals
- Because someone is going to be attacked and harmed or killed plus, especially these days, unhygenic, unhealthy to have people excreting there. Seen many close calls on my walks. Man sleeping completely across trail blocking woman pushing baby carriage. Man swinging heavy branch at woman jogging by. Well dressed black man covertly hiding behind theatre with 50ish woman pulling ragged carry-on luggage.
- Because walkable communities are sustainable and livable communities

- Better transportation options benefit everyone from the homeless to upper class, while also helping the environment.
- Buildings are run down. No access in the south.
- Cars and car-centric transportation design make it more difficult for people to reduce their reliance on cars, which we need to do to make the region more climate-proof.
- Changing climate will lead to less water resources available to all. Would like to see less lawns. New homes should have xeriscape or native plants only
- City is just turning into an expensive suburban sprawl and chain stores, in search of the almighty property tax dollar.
- Climate change is affecting our air quality.
- Climate change. Less noise, light, and air pollution from cars. Easier commutes without cars.
- Continues building downtown is causing congestion and changing the overall appeal of our city
- cost of living, protection of quality of life
- Crime is rising and with the weakened criminal penalty laws in our state, our police officers will need all the support they can get
- CRT teaches that kids are guilty of Racist racism of their skin color
- Current senior center is too far from Southeast Fort Collins
- depletion of Poudre River flows through town will negatively impact natural balance, whitewater park, Innovation Zone and River District, trails and natural areas that border the river - creating cascading economic and environmental distress
- Disabled left FoCo bc of lack of services and total unresponsiveness of Transfort staff.
- Diversity is important. I don't want this to be a town of only upper class rich white people. Regular people need homes!
- Diversity of Fort Collins needs to be seen by the city gov.
- Don't want to travel to another city
- Due to over developed areas, the roads can't handle the traffic.
- Effective public transportation is the best way to reduce emissions locally and also allow working and middle class people in Fort Collins to save money on the rapidly increasing costs associated with car ownership.
- Empowers people, helps environment and directly encourages the resident and city to work together and witness the miracle of composting! And it's fun
- Equality, safety and responsibility
- Even without further direct city intervention, I think over time this would increase the housing supply, and potentially allow more walkable/bikeable neighborhoods by improving accessibility to services.
- Even working 70 hours per week, I struggle every month to make ends meet.
- Everything else follows from working to combat climate change. We can't encourage people to enjoy going to the park or our natural areas for example, if they can't breathe the air. Hopefully we can work with surrounding communities and get aggressive on this. It's a big problem. Our individual actions help, but it's government, big corporations that have to make significant changes on this as well.

- Existing community members do not feel heard by the P&Z Board when new developments negatively impact us.
- FoCo is a desirable place to live, however, it seems like no one can move here anymore unless they are wealthy. Our family is growing, we have a combined income of \$115,000 per year, and that doesn't not qualify us for much in the Fort Collins area.
- Folks need to live where they work to reduce pollution and commute times
- For a city this size, it is inexcusable that so many areas have poor cell phone service. I never would have moved to southeast Fort Collins if I had known the cell phone signals are so weak. I emailed my city council representative after the T-Mobile temporary tower installed March 2022 still left my neighborhood with one bar of service, but she did not reply to me.
- fort collins is anti business
- Fort Collins is becoming unliveable for locals and college students
- Fort Collins is growing and the "growth issues" seem to be more visible. Traffic, homelessness, affordable housing, housing density overwhelms current roads and infrastructure.
- Fort Collins natives are being pushed out of the city due to the insane housing prices in Fort Collins recently. It's very sad and needs to be addressed.
- Gas prices, clean air
- Getting priced out of town
- Give households the option of participating. My household is below similar households in usage nearly every month and was before this was implemented. This is one reason I am thinking of moving to another community after living here for 29 years.
- Golf courses are overcrowded
- Health
- Housing is too exclusive and childcare is expensive which discourages young families from coming here
- Housing is too expensive
- Housing prices here are so high that it is a huge struggle for people who are already here to find new housing they can afford, for people who want to move here to do so, and for the growing number of unhoused people here to get any.
- I am a senior, housing keeps going up. Afraid to turn to be homeless
- I am disabled with an invisible disability (chronic illness, immune compromised) and would like to see more effort here, especially as the pandemic continues. This could look like initiatives and education for businesses to improve air quality indoors to reduce COVID spread as well as more typical accessibility initiatives
- I have lived in Fort Collins since 2018 and I wish the population was more diverse than it is. I think organizations like the BIPOC Alliance are helping however the city of Fort Collins should be doing more to address the lives, wants, and needs of the BIPOC and LGBTQ communities.
- I have seen the city allow residential development without demanding adequate roads for reasonable traffic flow within and entering/leaving development. This has had negative impacts on surrounding communities and created emergency evacuation concerns for impacted residents.

- I just don't want to see the city I and my family were born and raised in, falter. It's looking more and more like every other cookie cutter community on the map. Keep the city individual. We may be loosing our identity to the corporate mega ideology.
- I live on the edge of town and it's impractical to get anywhere without a car.
- I think it is an important part of dealing with our growth and is one area where the quality of life has degraded in my time in Fort Collins
- I think many of the locals know about this driving habit in the area, but when I first moved to the city I was almost collided with several times due to people running red lights. This is a massive safety concern for newcomers/tourists.
- I want to be prepared
- I want to continue to see Fort Collins be a safe city for all people.
- I want to know when composting will be widely available!
- I would use the bus more personally and I think a lot of other people would too. The city is large enough that we could benefit from a beefed up bus system.
- If strategically located, charge stations would promote nearby commercial enterprises as a place to visit during the charging wait time.
- If we don't take care of the environment, nothing else matters. (Please note that on your carpooling question there was no option for not using a car. We walk or bike)
- If you are going to continue to strengthen the community and make it a viable option for families, affordable housing is the only way. Houses starting at \$500,000 in this city is not only outrageous, but completely unsustainable and all the effort you put into the city will be for nothing. If no one can afford to live here no one will. Tourism will drop. Any sort of community and culture will vanish more than it already has. The building of ugly multi-million dollar condo buildings around old town has already taken a beautiful and historic area and made it another boring tourist trap, that only benefits the extremely wealthy. Focus on making this a city that everyday people want to live in and a community that is rewarding to be apart of.
- Improvements to local economy increase jobs and opportunities for all and reduce pressure on residents
- In 27 years of living here I've seen the Poudre River level sink considerably. Climate change forces us to protect a huge natural resource. Doing that increases the quality of life for all Ft. Collins citizens and businesses. Don't sacrifice our river to support downstream cities.
- Increased neighborhood cohesion (city feels very broken up by the major roads), safer biking for daily activities (e.g., grocery shopping) as opposed to recreational or trail riding, increased pedestrian safety, reduced noise and air pollution
- It impacts every foco citizen
- It is important due to the climate change around the world. We must do everything possible to minimize our impact to the environment.
- It is taking away from the charm of our city
- It seems that many or most manhole covers are big "potholes". I have a rough riding vehicle.
- It would make the building process easier and save valuable time for the builder and It would also save time for the city. You know time is money and saving time is saving money.

- It'd driving people out of the city
- It's currently unaffordable for the majority of socio-economic groups, which contributes to a lack of diversity and equity.
- It's dangerous to drive here, too many crashes, and it's only getting worse. Police do not seem to be present, so anything goes.
- It's safer and electric bikes already use the trails.
- I've only loved here for a year and a half and the growth is is crazy. Not enough grocery stores , shopping for the growth this is occur.
- I've watched this city over five years devolve into horrendous traffic, outrageous living situations and rents charged, and increase in violent crime especially in community areas like Old Town
- Keeping Ft Collins quality high
- Keeping power running on hot and cold days, improving traffic
- Lack of affordable housing
- Livability
- Livable cities need to dedicate LESS resources and land to cars (roads and parking lots).
- Living below the median income line in Fort Collins is challenging. Despite having a full-time job with a well-reputed institution in Fort Collins, my partner and I would not be able to afford a place to live without both of our incomes. This is without the consideration of if we had children or guardianship of a minor if we did, we would probably have to move. Though we're not San Francisco or New York City, some initiatives for renter protection or rent control would go a long way to protect low-income communities from the rise in the cost of living related to our fast population increase. We would theoretically like to purchase a home in Fort Collins and live here long term though this is becoming a more distant reality due to the skyrocketing prices of real estate. Having lived here for 6 years, I've witnessed Fort Collins rent and house prices rise; removing or mitigating some of the pressure that comes with finding housing in Fort Collins would allow those below the median income line to channel more time, energy, and money to the wonderful recreation, cultural, and community services offered by the city.
- Look at the turnover in City leadership. It's all new. They need to set a new tone of integrity for city employees in all departments.
- Low light, and or older eyes, need better marking on curbs for left-hand turns!!
- Making the city a better place to live in and move around in without a car addresses many problems at once: it's better for the climate, it helps even out social inequities, it provides everyone more access to education and job opportunities, helps strengthen the sense of community, etc.
- Many bad accidents and loss of life Speed limit is 55 most people travel 65 and even pass on the wrong lane.
- More employers, including manufacturing, brings in good paying jobs, that then bring in supporting businesses.
- My coworkers and I work closely with the city, but not for the city helping with downtown deescalation efforts of vulnerable populations and helping with homelessness solutions. While we make over minimum wage, in Fort Collins it's still not a living wage because the cost of living has skyrocketed tremendously. Ironically, this is the most money I've made from an hourly position. However, after paying for housing, utilities, and basic bills, there's very little left for food let alone savings. I'm

employed and have to lean on services and agencies to survive - is that how Fort Collins' wants its residents to thrive? I'm not alone and many people are struggling to get by having to take on 2-3 jobs. The cost of living in Fort Collins needs serious help!

- My elderly father had his car stolen. Less than 12 months later mine was stolen also. Fort Collins didn't used to be this way!
- Native Fort Collins residents are being forced out.
- Navigating better support for the success of community/cultural organizations helps lift the entire community; provides authentic feedback loops that move beyond outreach.
- Need people to be able to live here
- Need to keep up with growth
- Not enough affordable housing for senior citizens. Fixed income individuals have extreme difficulty accessing programming due to unrealistic income limitations.
- Not everyone agrees that climate change is the most important problem for Fort Collins.
- Not only are we filling up the landfill with perfectly good materials that could be reused, but some of these materials (like 1 inch thick wood flooring) is either unattainable or prohibitively expensive today and here we are chucking it out. That's insane. If a property owner doesn't want to reuse a building on their property, they should first try to find someone that will take it wholesale (and the City should help people to do this) or they should be required to dismantle it so the the parts can be reused. Other communities are requiring deconstruction of buildings rather than landfilling them. Why aren't we? We don't have an infinite supply of landfill, wood, energy, etc. that's required to demolish an old building, then harvest materials for a new one, process those materials, haul those materials, and install those materials. We've got to find ways to reduce the energy and resource waste involved with our built environment, and an easy fix is deconstructing rather than demolishing.
- Otherwise, we will soon become a haven of political elites that watch the 'paid help' leave the resort every night and return every morning to keep the resort fun, and full of craft beer and legal weed.
- Our entire family bikes to school and work, and it totally changes life. With more population density, there's less traffic, better affordability, less pollution, and more opportunities for jobs. It addresses a lot of problems in one.
- Over the last 10 -15 years the homeless problem has gotten worse and normal tax paying citizens have to feel threatened everyday when walking downtown. This is not the same city that it was just 15 years ago.
- Overall physical and mental health of the community.
- PEOPLE ARE DYING
- People cannot afford to live here and are commuting from all around. This harm's the environment, diminishes sense of community, and wastes people's time in their cars.
- People love this city, but they can't afford to live here if there's inadequate employment. The cost of living is dramatically increasing, and low wage jobs here are not sufficient for the people in the city.
- People should be able to afford to live in the community that they work in. Often, that is not the case now.
- People who grew up in Fort Collins can't even afford to live here. It's a sad world when you have to leave your home because it cost too much to live there.
- Poor job hiring City Manager

- Pricing of rentals, pricing of homes for sale, homeless issues
- Promotes local business development as well as greater access for a wider range of age ranges to access them.
- Pure safety.
- Reduction of water consumption is necessary to maintain our quality of life an our city's livability
- Rising cost of housing + stagnant incomes has created a dramatic increase in the cost burden to low and moderate income households. Our local economy depends on our workforce being able to live in the community in which they work, the widening gap between median renter income and median rent is making this an impossibility. More mixed developments and more density in supply will help fill in the "hole in the middle class." This would involve a change to the land use code to allow building up (upzoning) and less development of single family homes that are unaffordable to most and only serve to increase the dependence on single occupancy vehicles. Housing is the foundation for health, wellbeing, and educational success. A healthier and more educated populace benefits our economy by forming a more productive workforce.
- Safety of my kids
- Safety, improving Fort Collins and helping the unfortunate.
- Small crime is skyrocketing in Fort Collins and in ALL neighborhoods!!
- So I can continue to live here.
- So that all the people who work here can live here. So young people can afford to get into the housing market in Fort Collins. So that we don't become Boulder or Aspen.
- So that people of different socio-economic groups can be assured of a place to live and enjoy this wonderful city
- Specifically on the south side of ft Collins where there are not a lot of walk-able/bike-able areas and cars travel at speeds too fast. Besides this, the south side is the first impression of Ft collins for people coming from more populated areas or tourists traveling from the Denver airport coming to or though town.
- Supply doesn't meet Demand, at all.
- Sustainability is a necessity
- The availability and affordability of housing are significant factors when considering where to live. I fear that if housing continues on its current course it will eventually lead to the decline of the city as people move away for better opportunities.
- The balance is currently failing. Too much traffic for our roadways, over usage of our parks is causing destruction, ease of use of many items due to overpopulation is frustrating, etc.
- The bus service doesn't travel to necessary places
- The city has been so fixated on chasing new residents, getting on "best" lists, and pandering to developers and businesses that existing residents (especially us long-term residents who have been active participants) feel like they (by they I mean certain city council members) want to drive us out, raze our houses, build massive multi-family buildings, and pivot entirely to new residents who think this current state of affairs is just great.
- The city has stretched far outside its purview over the last decade. The city should focus on significantly shrinking its size and scope to allow for lower taxes and an improved standard of living for its citizens.

City policies are making it harder for a great number of citizens to be able to thrive in our once great city.

- The city is moving in the right directions and there are more important issues that are being worked on, where as is seems like nothing is being done on the excessive noise pollution in the city from modified mufflers to cars racing in norther Fort Collins
- The City of FC needs to identify the priorities in a world of limited resources. Stop catering to the lowest denominator.
- The city will fail if the working class cannot afford to live here.
- The last few years have been very tough, I'm sure these folks would not prefer to live in ditches, but need help. This will not only help them but our community as a whole for safety and comfort of our city.
- The traffic is terrible, and you never see police enforcing traffic laws.
- There are a few interrelated needs, all related to sustainability. They include: the need to come to terms with diminishing supplies of water while protecting the river and riparian habitats; addressing the chronic problem of unhealthy air pollution, which increasing numbers of automobiles worsens; and ending the externalization of costs related to land development in general and sprawl in particular. The latter is necessary for a functioning, fair economic system with adequate feedback mechanisms.
- There is currently no incentive for people to travel around Fort Collins without a car, which leads to poorer air quality and contributes to climate change. I have one bus stop near me that doesn't go anywhere I need to go. Riding my bike out of my neighborhood is terrifying because of poor bike protections on the south side of town. And sidewalks are uneven and never fully cleared in the winter. I have seen my elderly neighbors walk in the street on JFK because they can't use the sidewalk.
- This is my neighborhood and it should be a nice neighborhood. There are over 700 homes and the city keeps allowing for more developments in a neighborhood with only 3 exits. Traffic is terrible in this area, the park is forgotten because it's so far away from the city center. The weeds in the park are horrible, grass is dead, trees need maintenance. I feel like we are the forgotten, unimportant part of Fort Collins.
- This one change impacts many different city priorities. The densification of our community can increase affordability, reduce urban sprawl, reduce vehicle miles driven, reduce transportation maintenance costs, and improve community relationships. Corner stores and coffee shops should be allowed at intersections like Meadowlark/Swallow, Manhattan/Troutman, Dunbar/Swallow, Constitution/Stuart, Stover/Stuart, etc... - Trails are great once we get to them, but too many neighborhoods don't have safe access to them.
- Transportation is the lifeblood of a community. The ability to fly to and from Fort Collins efficiently is something worth acheiving. Otherwise, what are we paying for?

- Walking around my neighborhood is how I connect with others. When I can't walk (I broke my ankle in November), I become isolated and it decreases my quality of life. It is inequitable to have narrow sidewalks and unplowed streets. Please consider the entire community and make it safer for all of us!
- Want to be able to move about with limited automobile use
- Water is life. Also, the Poudre is central to Ft Collins, it provides our drinking water, aquatic recreation (fishing, kayaking, rafting, camping & picnicking) downtown business development & parks. It is also the only designated Wild & Scenic River in the state.
- Water, fire and air all impacted now by climate change.
- We are a society and need to keep the path and not fall into the politics
- We are running out of water.
- We don't have nearly enough low income housing.
- We need all kinds of people to make the community great. All kinds of people have different housing needs.
- We only have one planet. Every other concern is secondary.
- We should not be supporting economic growth of downstream communities in the greater Denver area at the expense of adequate water in the Poudre for community and enivronmental use.
- We will calcify into a rich little white enclave like Boulder if we don't. I want my kids to one day be able to buy a home here too. We need leaders with courage who encourage housing development, and recognize that selfish, loud, NIMBY property owners don't speak for everyone. How can the City, or

PSD, or CSU, or any non-profit, attract a dynamic workforce to help Fort Collins thrive if we can't realistically offer wages that enable home ownership, given the skyrocketing costs?
