
#### PROPOSAL DESCRIPTION

- 0.9-acre site currently used as a dirt parking lot for Wells Fargo employees.

- A proposal to pave and develop the site as a parking lot (PDP#160040) was approved by the Planning & Zoning Board (P&Z) in July 2017.
- The current proposal seeks to amend previously approved plans for the parking lot to permit the addition of two drive-in Automatic Teller Machines (ATMs).
