PROPOSAL DESCRIPTION

- This is a proposal to change the use of a Group Home into a Fraternity.
- Parking will be located behind the building and accessed from the existing alley.
- The project will require 2 parking spaces per three beds.
- The project will require an additional neighborhood meeting after a development application is submitted.
- This proposal will require review and public hearing by the Planning and Zoning Board (Type 2 review).
- The proposed land use will require a review and public hearing by City Council.
