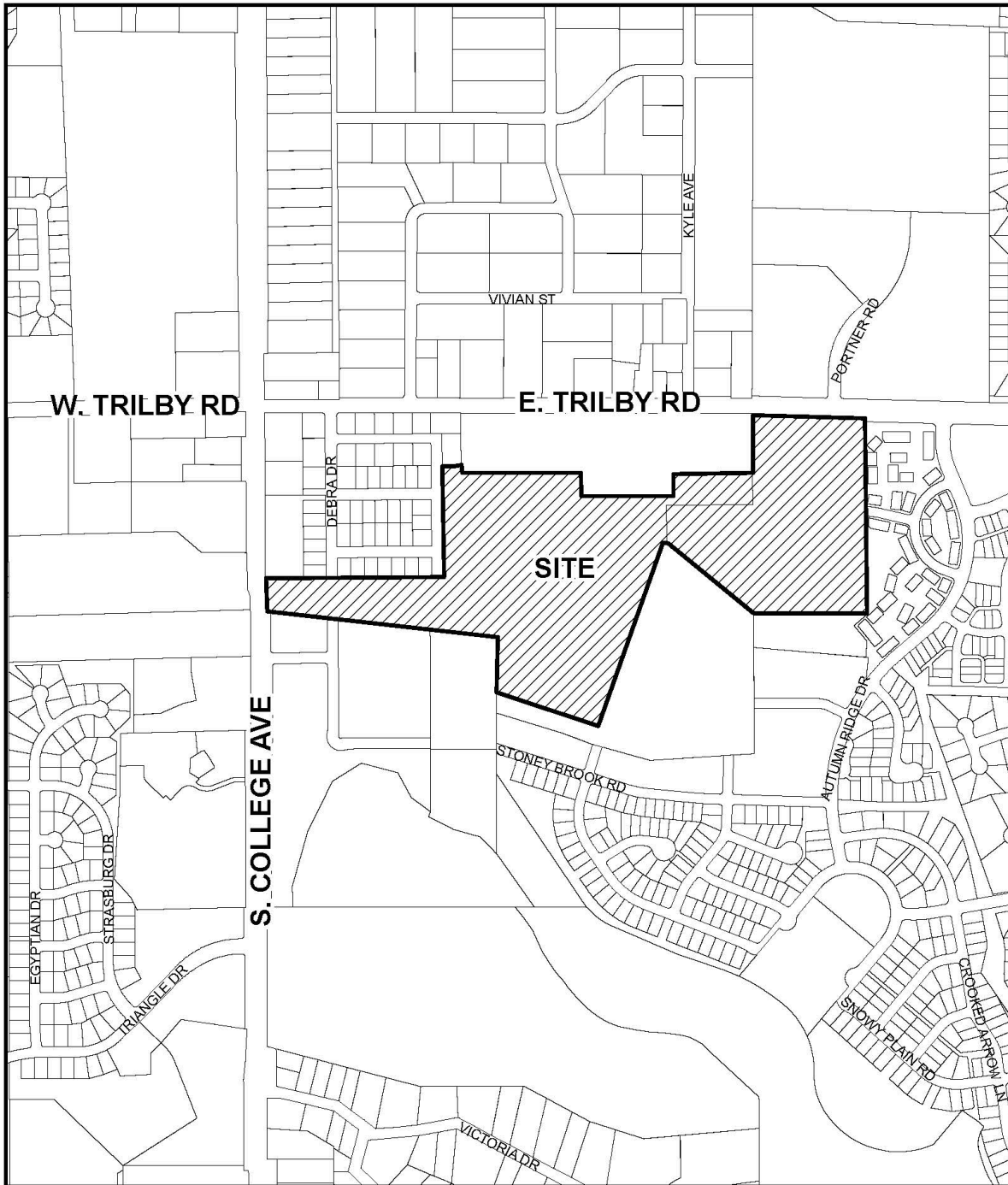

PROPOSAL DESCRIPTION

- This is a proposal for two modifications to the Land Use Code related to the potential development of a 211-unit manufactured home park to be developed, owned, and operated by Sun Communities.
- The site is approximately 50 acres within the Low Density Mixed-Use Neighborhood (LMN) Zone District.
- Before submitting a full application for a new manufactured home park, the applicants are requesting modifications to 1) the requirements for four different housing types in the LMN zone and 2) requirements for street-like private drives.
- This proposal will be subject to a review and public hearing by the Planning & Zoning Board (P&Z); residents who receive this letter will also receive a letter for the hearing.
