This letter is to let you know a public hearing has been scheduled to consider a development proposal near your property. Specific information about this development proposal is to the right and on the back of this letter. **This is a second hearing which modifies the original proposal to reduce the overall front façade height and side yard setback.** A decision regarding the approval or denial of the proposal will be made by an administrative hearing officer following the hearing.

City Council has authorized the use of remote technology for select hearings. You can participate over the phone, on the internet, or through the Zoom app on a smartphone, iPad, or computer. You do not need a paid Zoom account to participate. PROPOSAL DESCRIPTION

- The proposal is to construct a carriage house behind a street-fronting single-family residence.
- The plan proposes an 800 square foot building with two off-street parking spaces.
- The subject lot is 16,150 square feet in size.
- Access to the site will be taken from the existing alley.
- The project will preserve all existing landscaping on site.
