- This is a request to develop a threestory multi-family building, adaptive re-use of the two existing homes, and replat of Parcel 9714321001 and Parcel 9714321002 into a single lot.
- The proposed three-story multi-family Building 1 includes 50 studio and 1-bedroom units. Building 2 includes a 2-bedroom unit and 3-bedroom unit. Building 3 includes two 1-bedroom units.
- Access to the site is provided from West Prospect Road.
- The project is subject to a Type II review and public hearing by the Planning and Zoning Board.
