REGULATORY INFORMATION

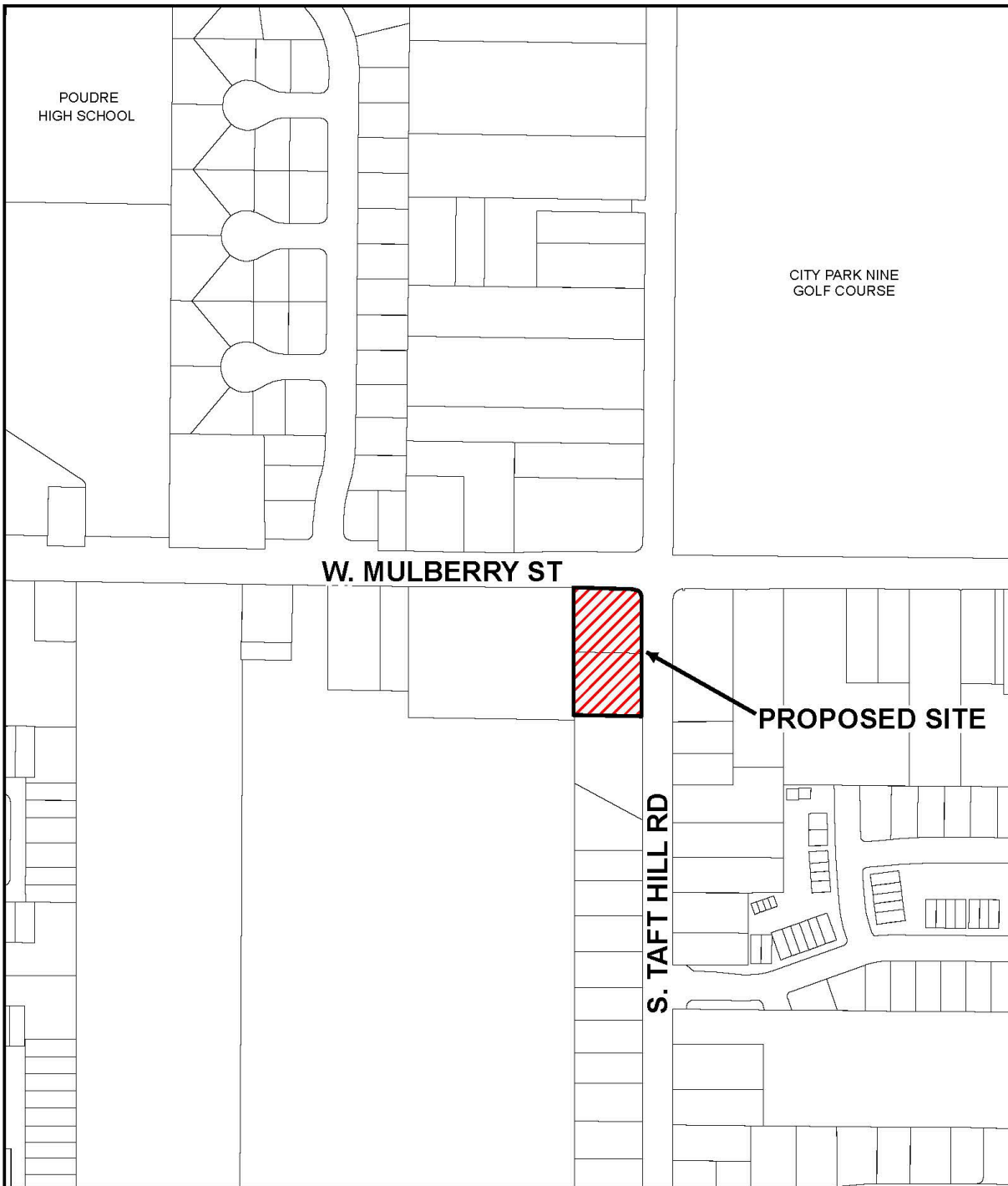
- A public hearing by the Planning and Zoning Board would be required for the project, with another mailed notice.
