### PROPOSAL INFORMATION

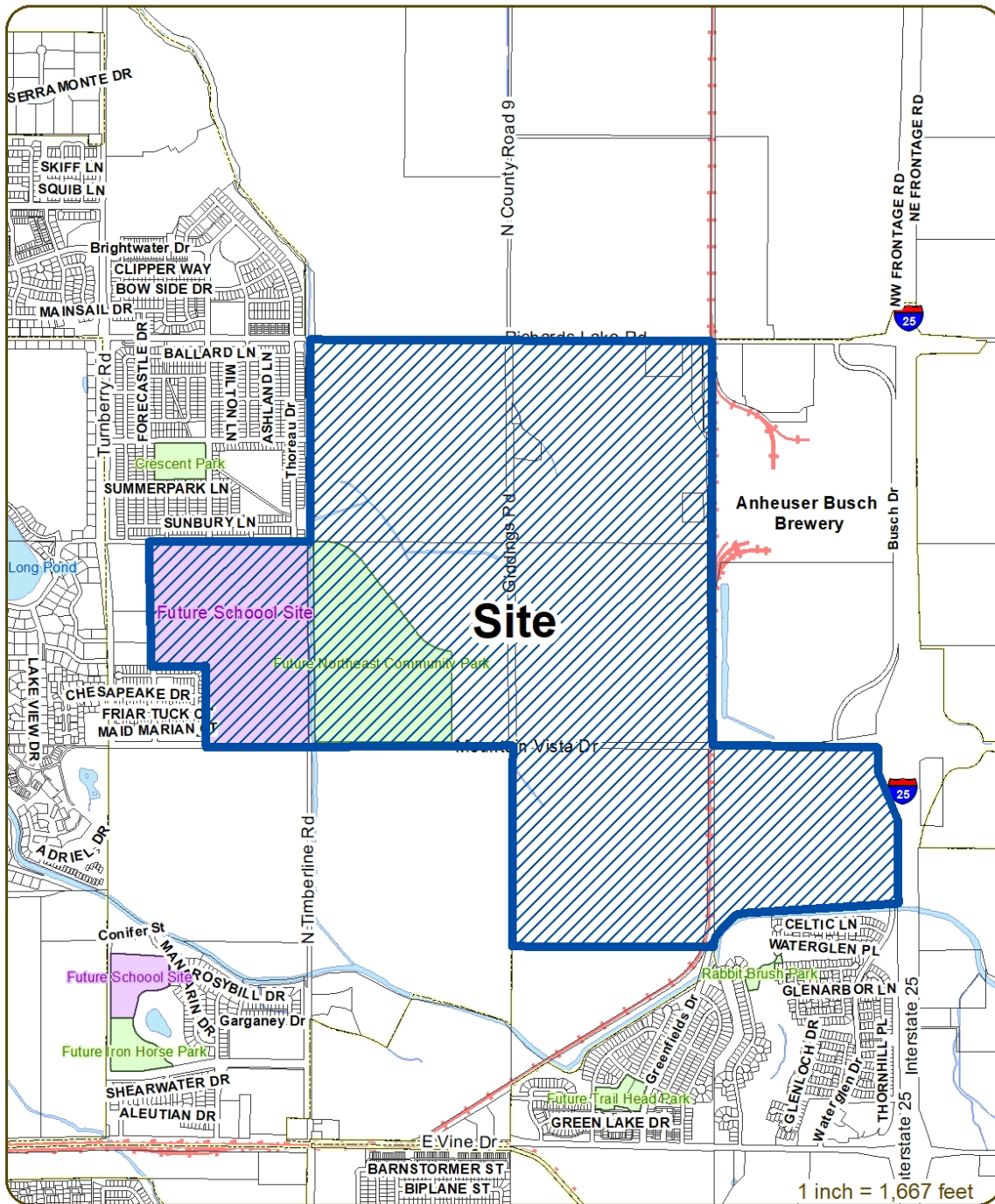
- Prospective development of approx. 999 acres in the Mountain Vista Subarea.
- Complete, connected community with new neighborhoods, town center, urban agriculture, commercial, employment, parks, trails, schools, and related transportation improvements.
- The Planning & Zoning Board heard this item on August 15th hearing and made a recommendation of approval to City Council.
- City Council will consider approval of a PUD Overlay and Master Plan, 3 City plan amendments, and a development agreement with extended vesting property rights.
- The development proposal consists of site-specific development plans, the approval of which may create vested property rights pursuant to Colorado law.

### ZONING INFORMATION

- The property is zoned Employment (E), Industrial (I), and Low Density Mixed-Use Neighborhood (LMN).
