#### **PROPOSAL NAME & LOCATION**

613 S. Meldrum St. Carriage House Modifications of Standards #MOD200001

#### PROPOSAL DESCRIPTION

- This was a stand-alone request for Modifications of five zoning standards applicable to carriage houses in the Neighborhood Conservation, Buffer (NCB) Zone District.
- The five zoning standards involve size limits for the scale and mass of carriage houses. The request was to enable a carriage house that would be larger than would be allowed under the zoning standards.
