- This is a Major Amendment (MJA) and Addition of Permitted Use (APU) for a 0.44-acre site currently used as a dirt parking lot for Wells Fargo employees.
- A previous proposal to pave and develop the site as a parking lot (PDP#160040) was approved by the Planning & Zoning Board (P&Z) in July 2017.
- The current proposal seeks to amend previously approved plans for the parking lot to permit the addition of two drive-in Automatic Teller Machines (ATMs).
- The project is subject to review and approval by the Planning and Zoning Board at a public hearing.


