### PROPOSAL INFORMATION


- This is a request to develop a 35-acre site located at the southwest corner of S. College Avenue and Triangle Drive.
- The plan proposes a combination of multi-family, duplex and townhome buildings totaling 362 residential units.
- Approximately 12-acres of the site will be preserved, enhanced, and protected as part of an effort to preserve existing wetlands, tree groves, and other significant natural habitat features.
- The construction of a traffic signal at the intersection of Triangle Drive and S. College Avenue will be required.
- The project is subject to review and approval by the Planning and Zoning Board at a public hearing.

 The site is in the Medium Density Mixed-Use Neighborhood (MMN)
 Zone District.
