This letter is to inform you that a **virtual public hearing on October 27, 2020** has been scheduled to consider an amendment to the approved development plan for the land between Greenfields Dr. and Campfire Dr. near your property. Basic information about this proposal is to the right and on the back of this letter. A decision regarding the approval or denial of the proposal will be made by an administrative hearing officer following the hearing.

PROPOSAL DESCRIPTION


- The amendment proposal is to change the current approved use from townhomes to singlefamily residences.
