PROPOSAL INFORMATION


- This is a Project Development Plan (PDP) for a vacant 15.7-acre site.
- The PDP proposes a total of 304 apartments and an amenity center.
- The PDP proposes a total of 509 vehicle parking spaces and 462 bicycle parking spaces.
- One modification is being requested to allow one of the buildings to be located more than 350 feet from a street sidewalk.
- This site is part of an Overall Development Plan (ODP) that designates this parcel for secondary uses; residential uses are a permitted secondary use in the HC zone.
- The project is subject to review and approval by the Planning and Zoning Board at a public hearing.

 The site is in the Harmony Corridor (HC) Zone District.
