PROPOSAL INFORMATION


- This is a request for a Site Plan Advisory Review (SPAR) for CDOT to construct new northbound and southbound Port of Entries as part of the I-25 North Express Lanes project.
- Existing frontage roads will be relocated, and new infrastructure will be installed to support the new Port of Entries.
- Each side will include an operations building, employee parking access from the frontage roads, truck scale, truck bypass and parking lanes, truck inspection area/covered inspection structure, and storage/operation areas accessed from I-25.
- The project is subject to review and approval by the Planning and Zoning Board at a public hearing.

 The site is in the Employment (E) and Public Open Lands (POL) Zone Districts.
