#### PROPOSAL INFORMATION


- This is a proposal to demolish the former Kmart building and construct a new 124,000 square foot supermarket including a drivethru pharmacy, grocery pick-up and café.
- The project also proposes the demolition of the existing gas station and former Radio Shack building which would be replaced by a commercial pad site along Drake and a gas station along College.
- The parking lot will be reconfigured to provide 452 parking spaces in which 100 will be shared with the Max Drake Station.
