This letter is to inform you that a **virtual public hearing on January 26, 2021** has been scheduled to consider a proposal to convert a duplex and townhome into a hotel near your property. A decision regarding the approval or denial of the proposal will be made by an administrative hearing officer following the hearing.

- Parking will be contained within three existing driveways and through a shared off-site parking agreement with the Presbyterian Church on Mason Street.


