PROPOSAL INFORMATION



- The proposed three-story multi-family Building 1 includes 48 studio and 1-bedroom units. Building 2 includes a 2-bedroom unit and 3-bedroom unit. Building 3 includes two 1-bedroom units. Access to the site is provided from West Prospect Road.
- The project is subject to review and approval by the Planning and Zoning Board at a public hearing.
