### **PROPOSAL INFORMATION**

- City Parks Department maintenance facility with office/shop building, and storage yard.
- Urban Estate zone district requires Addition of Permitted Uses (APU) to allow the office and outdoor storage uses in the zone.
- The APU requires a recommendation by the Planning and Zoning Board and a final decision by City Council.
- 3.6-acre site.
- Building would be 1-story, 6,000 sq. ft. with an 'urban agriculture' theme designed to be compatible with Bucking Horse.
- Amends the Bucking Horse Overall Development Plan at its far eastern point.
