

#### PROPOSAL INFORMATION

- This is a request to rezone 4.625-acres in the northeast quadrant of the I-25 and E Prospect Rd interchange.
- The site is currently zoned Urban Estate (UE), and the request is for placement into the Industrial (I) Zone District.
- This rezoning petition is one of three concurrent submittals updating and reflecting major changes to the area with the construction of Fox Grove and Poudre School District Campus, and abandonment of the frontage road.
- An associated Overall Development Plan amendment is filed under project # MA210006.
- The project is subject to review and approval by the Planning and Zoning Board at a public hearing.
