

PROPOSAL INFORMATION

- This is a request for a Site Plan Advisory Review (SPAR) to expand the existing Larimer County Alternative Sentencing (ASD) and Community Corrections (CC) facilities. A proposed two-story ASD/CC building expansion of approximately 50,500 square feet will include dormitories with 174 beds for the Alternative Sentencing and Community Corrections residential programs already located on site, as well as educational and administrative support space. A new parking area, walkways and landscaping are also proposed.
- The project is subject to review by the Planning and Zoning Commission at a public hearing. The property is in the Employment (E) and Transitional (T) Zone Districts.
