PUBLIC NOTICE — TWO-WEEK OPEN COMMENT PERIOD

August 17, 2021

Dear Property Owner or Resident:

The City of Fort Collins has received a request to replat the property addressed 4345 Corbett Dr, referred to as **4345 Corbett Dr Replat, #BDR210006**.

This is a request for a Basic Development Review to replat the property addressed 4345 Corbett Dr (parcel #8732407014) to create two lots, to place a building currently containing a Sprouts Farmers Market onto its own separate lot corresponding to its exterior walls. Access is taken from Corbett Dr directly to the east. The property is in the Harmony Corridor (HC) zone district (location map on reverse).

The Land Use Code Section 2.18 allows this request to be considered by the Planning Director administratively versus a public hearing. Prior to consideration by the Planning Director, there will be a two-week open comment period during which comments can be provided to the Planning Services Department. This open comment period will be:

8:00 A.M., Wednesday, August 18th through 5:00 P.M., Wednesday, September 1st

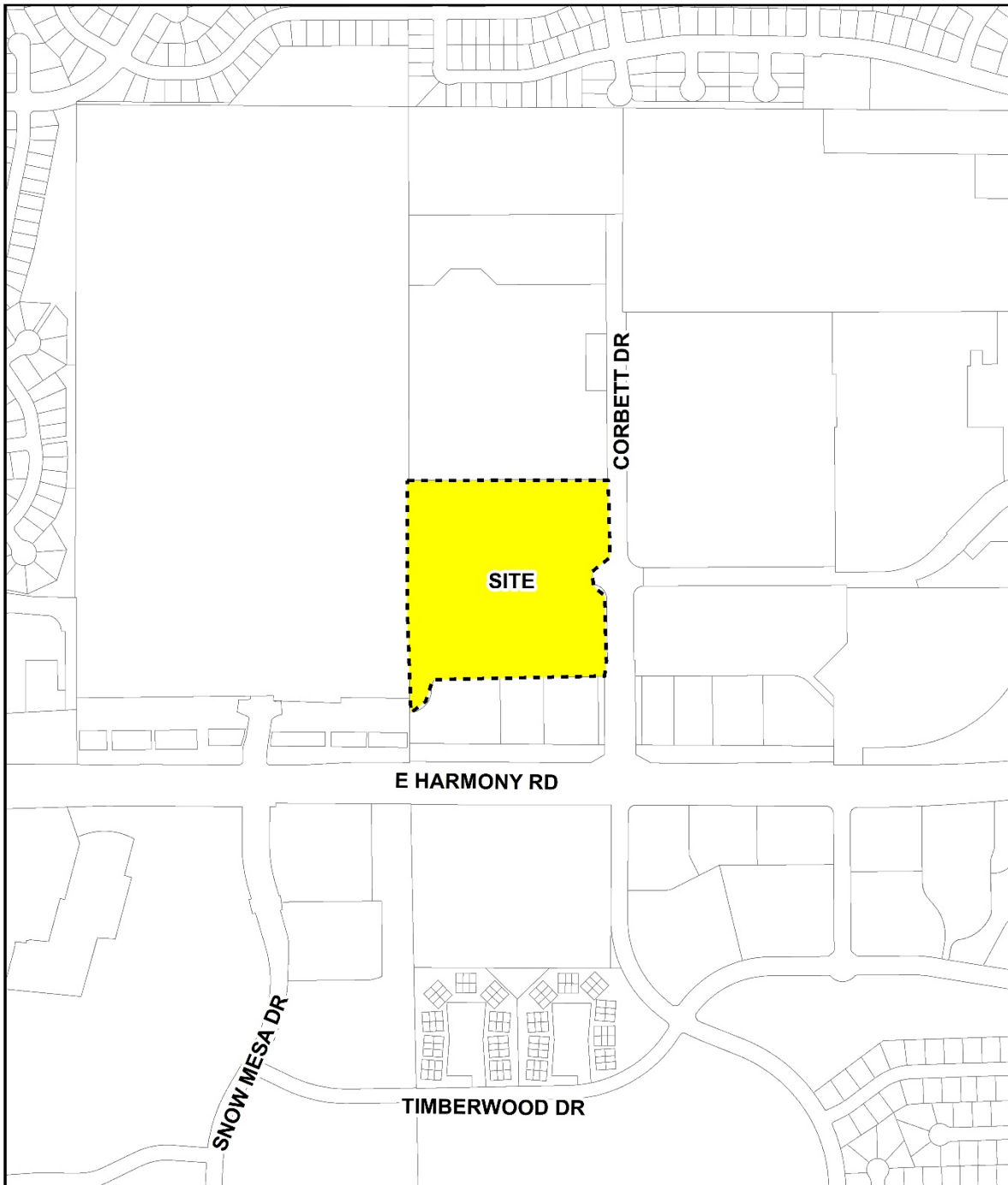
