## PUBLIC NOTICE — TWO-WEEK OPEN COMMENT PERIOD

August 27, 2021

Dear Property Owner or Resident:

The City of Fort Collins has received a request for a standalone Modification of Standards for the property addressed 728 Cherry Street, referred to as **728 Cherry Street**, **MOD210002**.

This is a request for a Modification of Standards to the minimum lot size requirement of 5,000 square feet. If the Modification is approved, the applicant would proceed with a BDR replat to create Lot A (5,651 square feet), and new Lot B (3,920 square feet and create an opportunity for a detached single-family dwelling unit). Access is taken from Cherry Street and existing alley directly to the east. The property is in the Neighborhood Conservation Medium-Density (NCM) Zone District, subject to Basic Development Review (location map on reverse).

The Land Use Code Section 2.18 allows this request to be considered by the Planning Director administratively versus a public hearing. Prior to consideration by the Planning Director, there will be a two-week open comment period during which comments can be provided to the Planning Services Department. This open comment period will be:

At the close of the public comment period, the Planning Director shall issue a written decision to approve, approve with conditions or deny the development application based on compliance with the applicable standards. The written decision shall be mailed to the applicant and to any person who provided comments during the comment period and shall also be posted on the City's website at <a href="https://www.fcgov.com/Proposals">www.fcgov.com/Proposals</a>.
