### PROPOSAL DESCRIPTION

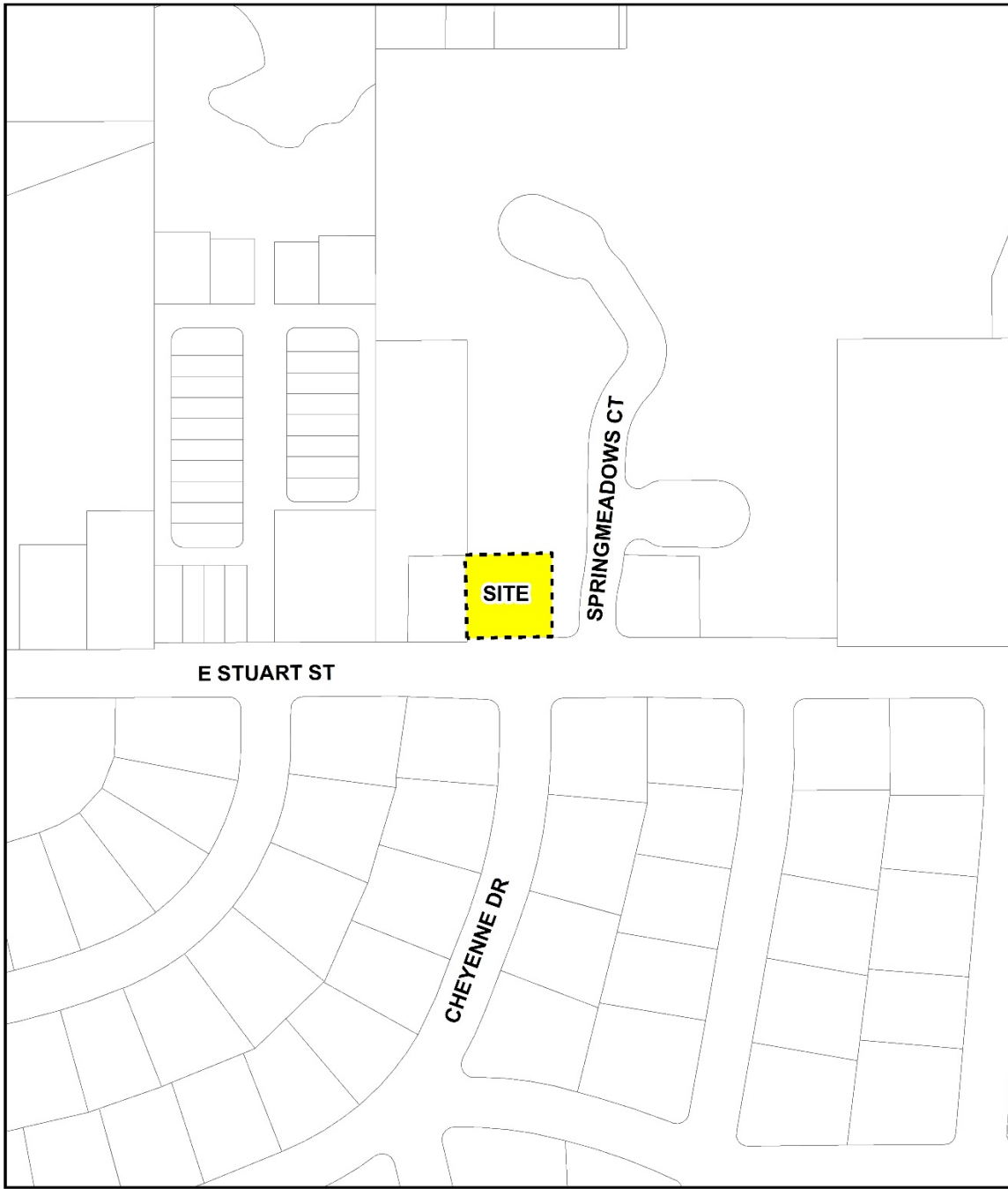
- The proposal is to convert the former Waldorf School into a 4-unit multi-family building.
