### PROPOSAL INFORMATION

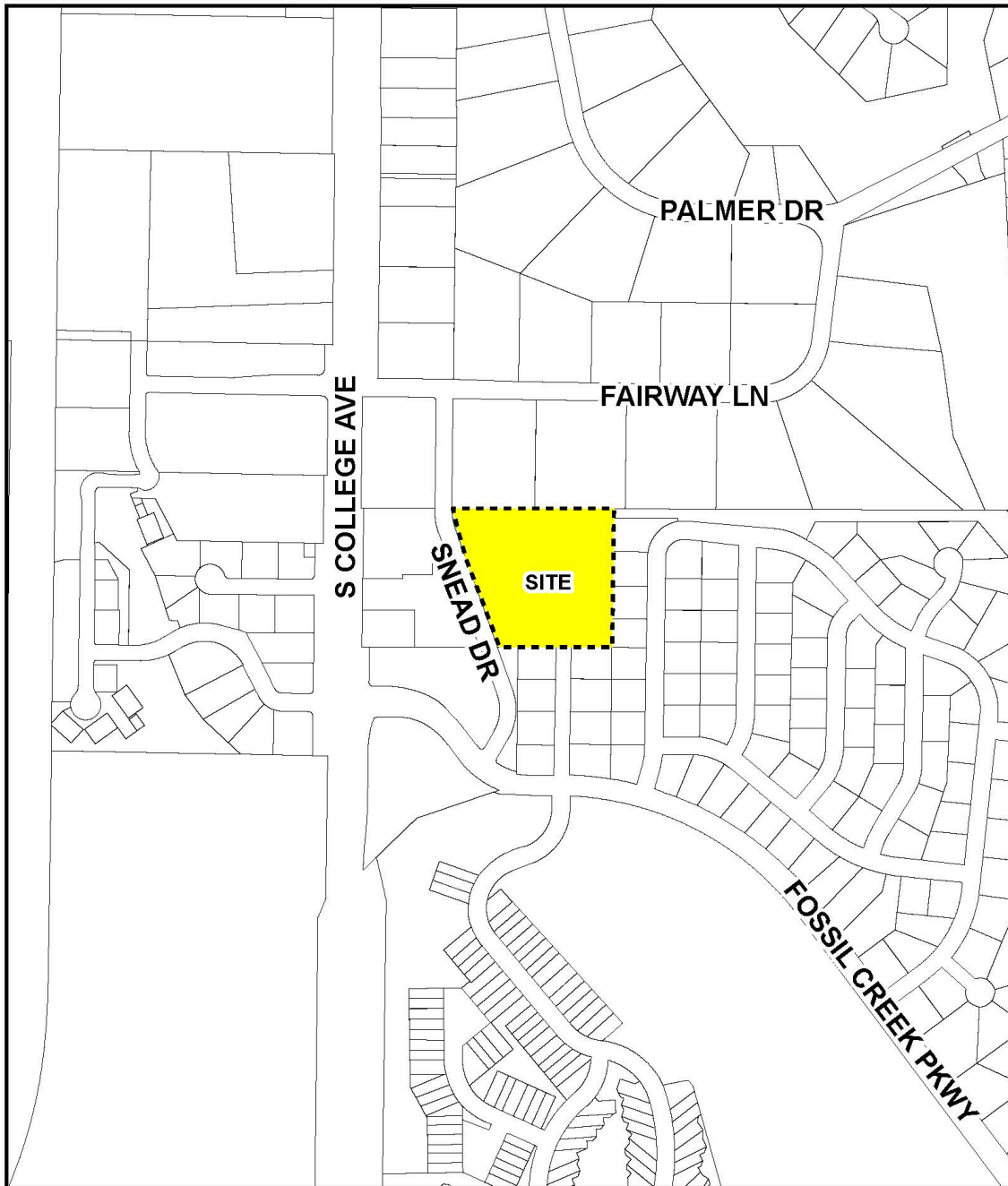
