

### PROPOSAL INFORMATION

- This is a request to develop 180 multifamily dwellings on 9.9 acres within the Timberline Church campus at 2908 S. Timberline Road. The plan includes seven multi-family buildings that are three stories in height. Six Modifications of Land Use Code Standards are proposed with the multifamily project.
- An Overall Development Plan (ODP) is also provided for the church campus.
- The site is within the Medium Density Mixed-Use Neighborhood (MMN) zone district and the proposal is subject to a Planning & Zoning Commission (Type 2) review and hearing approval.
