#### PROPOSAL INFORMATION


- Request to replat the 30.17 acre site into one parcel and development of 242 multi-family dwelling units, 1-acre park, clubhouse, and connections to the regional trail.
- The site will have access from Redwood Street, and internal local streets from existing subdivisions from the west and east.
- The PDP includes two requests for Modification of Standards for the building orientation and connecting walkway, and size of project for determining number of housing types required.

#### **ZONING INFORMATION**

The project is in the Low Density Mixed-Use Neighborhood (LMN), and Industrial (I) zone districts and is subject to a Planning and Zoning Board (Type 2) review.
