PROPOSAL INFORMATION

- This is a request to develop 243 multifamily dwellings on 8.13 acres at the southwest corner of Precision Dr. and Cinquefoil Ln.
- The plan includes nine multifamily buildings that are two and three stories in height, a central, 1.5-story clubhouse, pool, and amenity area.
- One modification of standards is proposed to exceed the 7-acre multifamily block limit.
- Access will be taken from LeFevre Dr. to the north and Brookfield Dr. to the east.
- This project requires review and a decision by the Planning and Zoning Commission at a public hearing.
