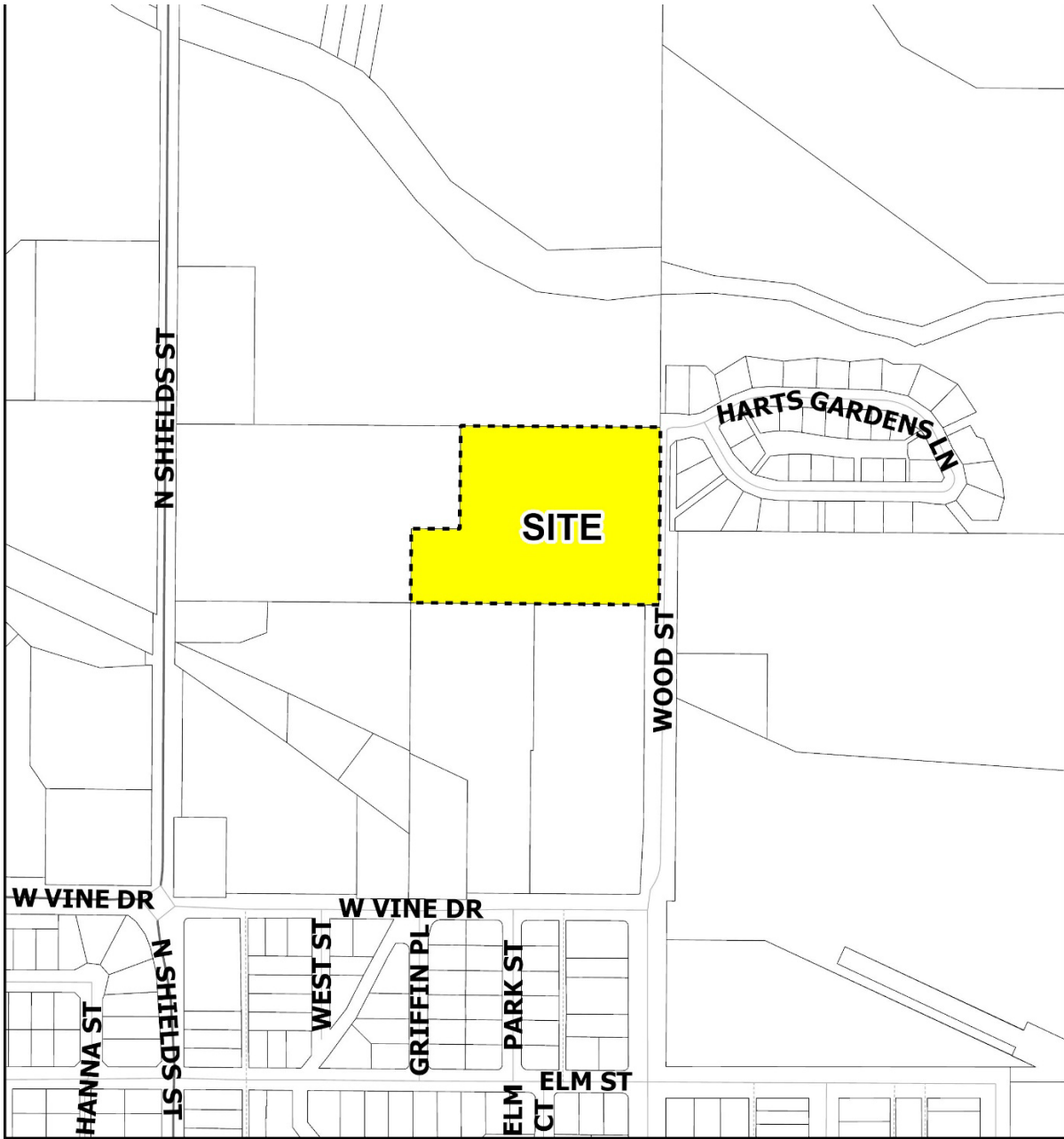
- This is a request for a Plat for a previously unplatted property and accompanies a minor amendment to the site.
