PROPOSAL DESCRIPTION


- This is a proposal to construct a 20" water main that will connect between the existing water mains in Vine Drive and Redman Drive.
- The proposed water main is meant to provide customers served by East Larimer County (ELCO) water district with adequate water pressure as the Mulberry Corridor continues to develop.
- This improvement is paid for by private development and will not affect water service or prices for customers within the ELCO water district.
- The proposal would require a connection into the water line under Vine Drive which is anticipated to cause a lane closure at a future unknown date.

ZONING INFORMATION

- The property is in the Industrial (I) Zone District.
- The proposal is a permitted use in this district and is subject to an Administrative Hearing.
