This letter is to inform you the Planning and Zoning Commission will conduct a new public hearing to consider the Ziegler-Corbett Overall Development Plan Major Amendment proposal near your property. The original March 23, 2023, approval was appealed to City Council on August 15, 2023, with direction to conduct a remanded hearing and consider stubbing a local street connection that could eventually connect north to Paddington Road. Basic information about this development proposal is to the right and on the back of this letter. A decision regarding the approval or denial of the proposal will be made at the hearing.

The hearing will be held on-site in Council Chambers, City Hall as well as virtually through Zoom. You can participate over the phone, on the internet, or through the Zoom app on a smartphone, tablet, or computer. You received this notice because records from the Larimer County Assessor's Office indicate you own property near the proposed development site.
