## PROPOSAL INFORMATION

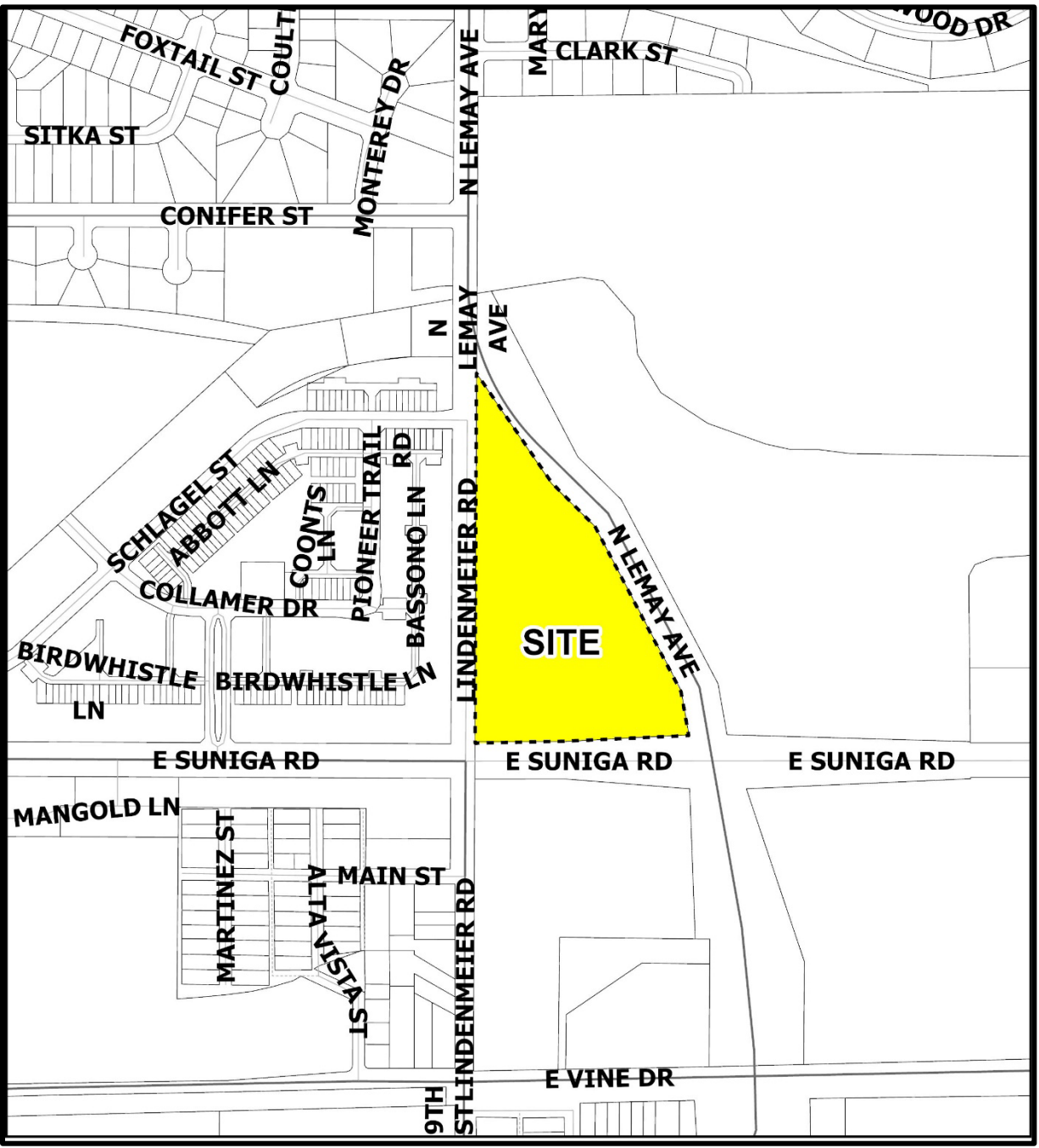
- The proposal is for 6 multi-family buildings, all 3 stories in height, with a total of 267 units directly north of E Suniga Rd and E of N Lemay Ave.
