

PROPOSAL INFORMATION

- This is a request for a residential cluster development in the Urban Estate (UE) Zone District.
- The plan is for a subdivision with 66 houses on the 19 acres with 33% of the land as open space around the edges.
- A trail connects Soft Gold Park on the south to Willox Lane on the north, along the eastern edge of the site.
- Utility services come from Hickory Street ¼ mile to the south, through Soft Gold Park.
- The plan includes two modifications of standards.
