### PROPOSAL DESCRIPTION

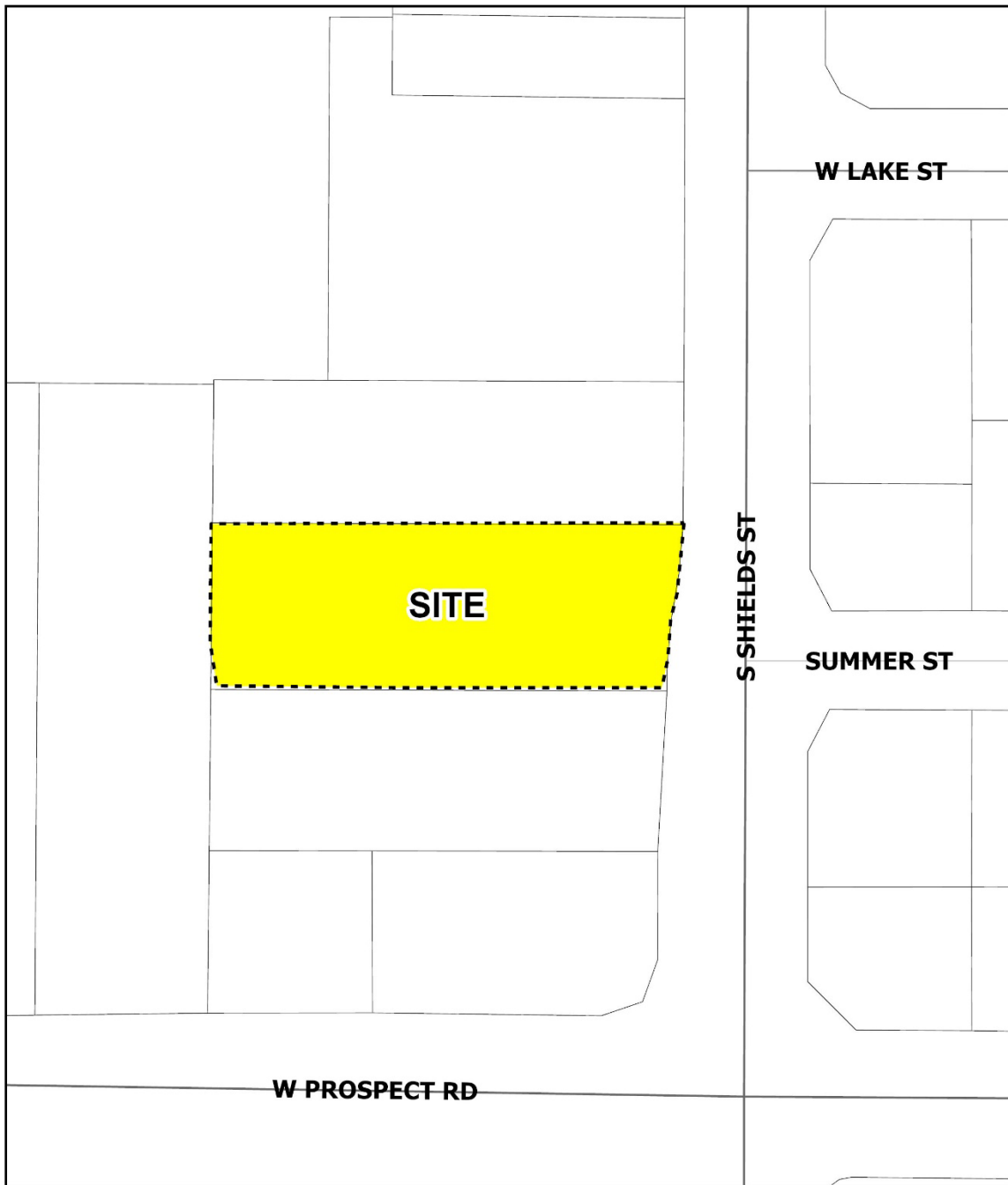
- The proposal is to convert the existing single-family home to a multi-family building.
